Mr Steve Howard Secretary General, The Global Foundation

As Founding Secretary General of the non-profit Global Foundation since 1998, Steve Howard has led the necessary global push for the adoption of 'co-operative globalisation', a positive strategy for inclusive, 'win-win' economic development and a sustainable global economy.

Many world leaders have personally participated in and endorsed this and related initiatives.

Through this collaborative and low-key approach, Steve has helped to shape global affairs with practical outcomes over more than 20 years.

Prior to the Global Foundation, he led the successful renaissance strategy for Melbourne, in Australia in the 1990's, including a national strategy for private sector investment in public infrastructure, now adopted as a business model, worldwide.



Ms Sue Kench Global Chief Executive, King & Wood Mallesons

Sue Kench is the Global Chief Executive of King & Wood Mallesons. She leads the development and implementation of the firm's international growth strategy and is responsible for integrating the firm's international operations.

Together with the Global Chairman, Sue oversees the firm's International Management Committee and the Global Executive team which are responsible for setting the firm's strategic priorities and international business plans.

Sue has a reputation for driving positive change, aligning and engaging diverse groups around a

shared vision and creating a culture where everyone has a voice.

Her leadership was recognised by the Financial Times when she received the 'Australian innovative leader award' at the FT Asia Pacific Innovative Law Firm awards in 2018. She was also named in the 2018 Australian Financial Review's 100 Women of Influence.

Sue was appointed Global Chief Executive in 2017 following four years as Chief Executive Partner Australia where she led a very successful growth agenda.



Mr Kishore Mahbubani

Author, Speaker, Academic, and Former Diplomat

Kishore Mahbubani is a Distinguished Fellow at the Asia Research Institute (ARI), National University of Singapore (NUS).

Mr Mahbubani has been privileged to enjoy two distinct careers, in diplomacy (1971 to 2004) and in academia (2004 to 2019). He is a prolific writer who has spoken in many corners of the world.

In diplomacy, he was with the Singapore Foreign Service for 33 years (1971 to 2004). He had postings in Cambodia, Malaysia, Washington DC and New York, where he twice was Singapore's Ambassador to the UN and served as President of the UN Security Council in January 2001 and May 2002. He was Permanent Secretary at the Foreign Ministry from 1993 to 1998.

As a result of his excellent performance in his diplomatic career, he was conferred the Public Administration Medal (Gold) by the Singapore Government in 1998.

Mr Mahbubani joined academia in 2004, when he was appointed the Founding Dean of the Lee Kuan Yew School of Public Policy (LKY School),

NUS. He was Dean from 2004 to 2017, and a Professor in the Practice of Public Policy from 2006 to 2019.

In April 2019, he was elected as an honorary international member to the American Academy of Arts and Sciences, which has honoured distinguished thinkers, including several of America's founding fathers, since 1780.

Mr Mahbubani was awarded the President's Scholarship in 1967. He graduated with a First Class Honours degree in Philosophy from the University of Singapore in 1971. From Dalhousie University, Canada, he received a Master's degree in Philosophy in 1976 and an honorary doctorate in 1995. He spent a year as a fellow at the Center for International Affairs at Harvard University from 1991 to 1992.

He has also been a prolific author, having published eight books: *Can Asians Think?*, *Beyond The Age Of Innocence*, *The New Asian Hemisphere*, *The Great Convergence*, *Can Singapore Survive*, *The ASEAN Miracle* (co-authored with Jeffery Sng), *Has the West Lost It?* and *Has China Won?*.



Madame Fu Ying

Chairperson, Center for International Security and Strategy, Tsinghua University (CISS)

Fu Ying started her career with China's Ministry of Foreign Affairs (MFA) in 1978 and had long engaged in Asian affairs. She served successively as Director of Division and Counselor in Asian Affairs Department of MFA.

In 1992 She joined UN peacekeeping mission in Cambodia. She was appointed Minister Counselor at Chinese Embassy in Indonesia in 1997, Chinese Ambassador to the Philippines in 1998, and Director General of Asian Department of MFA in 2000. She then was appointed Ambassador to Australia (2004-2007), and Ambassador to the United Kingdom (2007-2009).

She served as Vice Minister of Foreign Affairs for European Affairs and then for Asian Affairs (2009-2013).

Fu Ying was elected deputy to China's 12th (2013) and then 13th (2018) National People's Congress (NPC). She was the Chairperson of the Foreign Affairs Committee and spokesperson of the 12th NPC (2013-2018).

She is now a Vice-Chairperson of the Foreign Affairs Committee of China's 13th NPC (2018-2023).

Fu Ying also serves as the Chair of Center for International Security and Strategy (CISS) since 2018, and appointed an adjunct professor at Tsinghua University in 2018. She was appointed the Honorary Dean of the Institute for AI International Governance of Tsinghua University (I-AIIG) in 2020.



Mr Didier Borowski Head of Global Views, Amundi

Didier Borowski joined Amundi in 2010 as co-Head of the Strategy and Economic Research team and was appointed Head of Global Views in 2019, a team, which supports General Management and the Global Investment Committee and aims to strengthen Amundi's thought leadership on key cross-cutting thematic.

Prior to that, Didier held a position of at the French Treasury. He also worked as an expert for the European Commission.

Didier holds a PhD in economics and was Associate Professor at the University of Paris Nord and lecturer for several years at the University of Paris Dauphine.



Dr Keyu Jin Associate Professor, London School of Economics

Dr. Keyu Jin is a tenured professor at the LSE, where she researches and teaches International Economics, technology competition and the Chinese Economy.

She is a board member of Richemont Group, one of the largest luxury conglomerates in the world. She has contributed multiple op-ed pieces to the Financial Times, and served on the editorial board of the Review of Economic

Studies, one of the world's leading Economic journals. She has made documentaries for the BBC on Artificial Intelligence and US China Technology competition and a solo documentary feature for Bloomberg, representing a new voice of China.

She has taught at Yale and Berkeley in the past, and has a BA, MA, PhD from Harvard University.



Mr John McCarthy, AO

Senior Adviser, Asia Link; former Australian Ambassador to India, Indonesia, Japan, Thailand and the United States

John McCarthy AO is a former Australian career diplomat. He joined the then Department of External Affairs in 1968.

McCarthy's posts include Ambassador to Vietnam, Mexico, Thailand, The United States, Indonesia and Japan and High Commissioner to India.

His assignments in the Department of Foreign Affairs and Trade (DFAT) in Australia included Chief of Staff to the then Foreign Minister, Andrew Peacock, Chief Legal Officer and Deputy Secretary.

Born in Washington DC in 1942, McCarthy has an MA and LLB from Cambridge University and was called to the London bar at the Middle Temple in 1965. He was a barrister in London from 1965 to 1966 and worked for the New York law firm of Shearman and Sterling from 1966-1967.

Since leaving DFAT in 2009, McCarthy has been: National President of the Australian Institute of International Affairs; Chair of the Australian Australia-India Council; Co-convenor of the Australian-Indonesia dialogue; and Chair of the Advisory Board of the Griffith Asia Institute.

After 2009, McCarthy has also had a number of assignments from the Minister of Foreign Affairs and has been involved in the private sector, including as senior adviser to Mitsubishi Materials Corporation, Tokyo, since 2011.

McCarthy is a senior adviser to Asialink

McCarthy is an Officer of the Order of Australia (1999). He has Honorary Doctorates from Murdoch and Griffith Universities. .



Mr Jean-François di Meglio

President, Asia Centre, Paris

JFDM is currently chairing ("President") of the Paris-based, Asia-focused think-tank Asia Centre which he contributed establishing in 2005 and has been heading since 2009 (www.centreasia.eu).

Within the institution he particularly focuses on Greater China on the political, financial, economic, energy and environment fronts. He regularly contributes to French and international media.

Asia Centre is an independent think-tank which

issues a quarterly "Asia Trends" in both French and English, next issues of which will focus on contemporary political Chinese thinkers on both sides of the Straits and in Hong Kong as well as on issues related to the Korean peninsula (both issues to be released last quarter 2021, available on request)

JFDM is an alumnus of Paris Ecole normale supérieure and Beijing University. He previously had a banking career in North America, Europe and North East Asia.



Dr Selena Ng

Advisor, Social Economy; Member of the Board, the Global Foundation

Born in Australia to Malaysian parents in 1980, Selena grew up in rural Victoria where her fascination with the universe led her via Monash University to a PhD in string theory at the University of Cambridge in 2002. Her focus on “where do we come from?” and “what will we become?” soon turned into “what do we want to become?” and “how do we make that happen?”.

An MBA at the Collège des Ingénieurs led her in 2004 to join AREVA, a global leader in the nuclear power industry. Her career at the AREVA group has ranged from leading a France-US technical collaboration on nuclear non-proliferation to creating a regional office in Singapore to advise South-East Asian

countries on developing nuclear power safely and sustainably, and more recently to constructing very large (~1600 MWe) nuclear power plants, first in France, then in Finland and now in the UK.

Selena is a keen advocate of “teaching others to fish” and has been, in addition to coaching her teams and other colleagues, an active volunteer in strategic planning for grassroots organisations in rural Benin and Malaysia, financial planning for domestic workers in Singapore, and increasing self-esteem for less privileged teenagers in France. Her guiding aspiration is to create sustainable and positive change in all that she does: situations and people, profit and nonprofit, big and small.



Dr Dino Patti Djalal

Founder, Foreign Policy Community of Indonesia and Former Deputy Foreign Minister, Republic of Indonesia

Dino Patti Djalal was born in Belgrade, Yugoslavia on 10th September 1965. He earned his Bachelor's Degree in Political Science from Carleton University (Ottawa, Canada); a Masters Degree in Political Science from Simon Fraser University (Vancouver, Canada), and a Phd in International Relations from the London School of Economics and Political Science (London, UK).

In 2004, Dino was appointed Special Staff of the President for International Affairs. In that capacity, Dino assumed many roles: Presidential spokesperson, foreign policy

adviser to the President, speech writer.

From 2010 to 2013, Dino served as Indonesia's ambassador to the United States.

In 2012, Dr. Dino won the prestigious “Marketeer of the Year”, the same award that was won by President Joko Widodo.

In June 2014, Dino was appointed Vice Minister for Foreign Affairs, until October that year. In 2015, he has founded the Foreign Policy Community of Indonesia.



Tan Sri Michael O.K. Yeoh President, KSI Strategic Institute for Asia Pacific

MICHAEL YEOH is a public intellectual, social entrepreneur, author and international speaker.

He has over 35 years of senior corporate management, consulting and boardroom experience. Currently he is President, KSI Strategic Institute for Asia Pacific, an independent non-profit Think Tank. He was previously CEO of the Asian Strategy & Leadership Institute. He is also Deputy Chairman of the Economic Club of Kuala Lumpur and a Director of the Malaysia China Business Council and the British Malaysia Chamber of Commerce and General Committee member of the Malaysian International Chamber of Commerce and Industry.

Michael sits on the Board of Directors of MUI Properties (Property Development), Pan Malaysia Corporation (Investment and Food), and Kashtec Holdings (Fintech and e-Commerce) and is a Trustee of the OSK Foundation and Yayasan Wesley. He was a Former Director of Star Media Group, the National Heart Institute and Sunway University.

Michael has served the Government as

Malaysia's Representative (Ambassador rank) to the ASEAN High Level Task Force on Connectivity, Commissioner in the Royal Commission of Police, Member of the Malaysia Competition Commission, member Advisory Board of the Malaysian Anti Corruption Commission and Commissioner in the Human Rights Commission (SUHAKAM). He was a member of the National Unity Consultative Council and was recently appointed to the Executive Council of the United Nations ESCAP Business Sustainable Network.

He has authored 5 books and have spoken at forums organized by the World Economic Forum, Confederation of Indian Industry, Centre for China and Globalization, the Asia Society, the China Development Institute, World Policy Conference and Oxford and Cambridge Universities.

He holds a degree in Economics from Monash University and Doctor of Laws (honoris causa) from the University of Nottingham. He has also attended senior management courses at Wharton School and Harvard Business School.



Professor Peter Yu Vice-President, First Nations, Australian National University, Australia

Peter Yu is a Yawuru man from Broome in the Kimberley region in North West Australia with over 40 years' experience in Indigenous development and advocacy in the Kimberley and at the state, national and international level. Peter was a key negotiator on behalf of the Yawuru Native Title Holders with the Western Australian State Government over the 2010 Yawuru Native Title Agreement. He was recently Chief Executive Officer of the Yawuru Corporate Group and is the current and inaugural Professor and Vice – President First Nations Portfolio at the Australian National University.

He has been an advocate for the social, cultural and economic advancement and well-being of Kimberley and other Aboriginal

communities for his entire career. He has been instrumental in the development of many community-based organisations and initiatives which have had an enduring influence on the Kimberley region. He was Executive Director of the Kimberley Land Council during the 1990s and a member of the national leadership team negotiating the Federal Government's response to the 1992 Mabo High Court judgement on Native Title.

He is currently the Chair for the Indigenous Reference Group (IRG) to the Northern Ministerial Forum, Deputy Chair of the North Australian Indigenous Land and Sea Management Alliance Ltd (NAILSMA), Board member of Jawun.



Mr Robert Knott Chairman, GHD

Mr Knott is Chair of GHD, an employee owned global professional services company with more than 10,000 people around the world and revenues of AUD 2.2 billion.

He previously led the company's operations in Asia-Pacific, spanning New Zealand, Philippines, Chile, and China. He has played a key role in mergers and acquisitions, which have diversified the company's earnings across the United States, Canada, Asia-Pacific, and the United Kingdom.

Mr Knott has more than 30 years' experience

in the design and project management of major water and transport infrastructure, defense, telecommunications, and property and buildings projects.

Mr Knott is a founding director of The GHD Foundation an independent global charitable organisation focussed on relieving poverty and distress and building communities. He is also director of Hands and Feet, an Australian charity providing food distribution, indigenous education, and national disability services.



Minister Shutaro Omura Minister, Deputy Head of Mission, Embassy of Japan, Australia

Minister Shutaro Omura is the current Deputy Chief of Mission at the Embassy of Japan in Canberra, Australia since being appointed in September 2018.

Prior to this assignment, Minister Omura had previously worked at the Ministry of Foreign

Affairs in Japan, served at the Permanent Mission of Japan to the United Nations, New York, USA, and served twice at the Embassy of Japan in Bangkok, Thailand.

Minister Omura obtained a bachelor's degree in law from the University of Tokyo, Japan."

Wymen Chan is Managing Director of SUSI Partners' Asia Investment Team, overseeing the company's investment activities in Southeast Asia.

Mr Cyrille Arnould

Cyrille Arnould joined the newly created EIB's Climate Office in March of 2020 after having led EIB's Global Energy Efficiency and Renewable Energy Fund since 2008.

Previously, he was a Senior Officer in the Africa Caribbean and Pacific department where he oversaw the development of private equity and microfinance portfolios. He came

to EIB from the World Bank's IFC in 2003.

Cyrille is a graduate of the Political Science Institute of the University of Strasbourg and holds a Master's in Law from the University of Strasbourg, as well as an MBA from the Wharton School of the University of Pennsylvania.
