The Assisi & Rome Roundtable

The Agenda for the Assisi & Rome Roundtable builds upon our recently circulated roundtable Update: 'Navigating the unknown, together, towards peaceful, global co-existence', along with extensive consultations with our supporters.

The roundtable meeting has been designed as one continuous and cumulative program, with all participants contributing throughout. Our modus operandi is to foster an interpersonal dynamic within the limited group of 40 or so participants who will take part.

Most will having multiple opportunities to contribute through informal remarks, some of which may be prepared in advance. Contributions, however, should be generally delivered from a seated position around a large table, for which notes may be referenced, although the reading of speeches is not encouraged.

A number of participants will be invited, in advance, to moderate sections of the meeting, others to make opening remarks to stimulate open discussion in the respective sessions.

The roundtable will be conducted in English only. There will be table microphones, to assist everyone being able to hear clearly.

The frame of reference that guides the work of the Global Foundation

As a not-for-profit, global, civic body, that relies upon generous and enlightened private sector support, the Global Foundation has the goal of serving the global common good, by acting as a catalyst in bringing together leaders, around a set of agreed principles and strategy.

As most taking part would already be aware, the Foundation is committed to a central, mobilising idea, of *cooperative globalisation*, that is, to promote a sustainable form of globalisation that is both renewed and remade around four principles. These principles, for a sustainable and lasting globalisation, are as follows: *transformative*, *fair*, *inclusive* and *prosperous*.

Many world leaders, including at our previous global roundtable meetings, have specifically endorsed these principles and the associated work of the Foundation. See <u>here</u>, for example, for the remarks made by Pope Francis at our 2017 Rome Roundtable meeting. Also, in a related way, see <u>here</u> the recent remarks about **business with purpose** and the role of business in society, by the outgoing Chief Executive of Anglo American, Dr. Mark Cutifani, who will again play a leading role at our roundtable.

In summary, the Foundation acts by bringing together, from time to time, leading figures from diverse backgrounds, so that they may share and, in turn, benefit from aligning their own efforts around these principles. At the same time, participants report on their efforts or intentions to manifest the cooperative globalisation strategy in their respective spheres of interest which, in many instances, are much more impactful than if acting alone.

The tools and talents that the Foundation seeks to bring to bear are those of the private sector and civil society, working in partnership with each other and with governments, both local, national and internationally. Importantly, our work is also faith-enabled, open to the contributions of all faiths and belief systems to inspire our work. In fact, the Foundation has long championed the concept of 'Dialogue between Civilisations', to seek common ground among those who may be informed by quite different faith and belief systems.

In this way, the Global Foundation is a facilitator and an encourager of those who are already committed to serving the common good. They see advantage in coming together and discussing the challenges and opportunities that the world at large is facing, then converting good intentions into practical and, in many cases, measurable actions. Our roundtable discussions will also include sessions on measuring progress.

Why Assisi, and then Rome? Integral ecology & the Assisi Accord:

The idea of meeting in a small village such as Assisi draws from a number of sources, including the notion that by stepping back for a few hours from the hustle and bustle of regular daily life, it becomes more possible to enjoy time for reflection and personal interaction, in a peaceful and stimulating environment.

Assisi, under the leadership of dynamic Mayor Stefania Proietti, is already legendary as a global village of peace, a crossroads for many who are active in promoting numerous international peace initiatives.











At this critical time in world affairs, the spirit of peace that Assisi represents is vital, both in terms of addressing immediate international conflicts and also in helping to avoid a further downward spiral in underlying strategic tensions that affect the geo-political scene.

Over and above this, Mayor Proietti has a vision for Assisi to become a global centre of integral ecology, a hub of activity for a sustainable planet where humanity cares for and acts in favour of our common home.

The Mayor's vision is echoed by many significant voices, most notably, Pope Francis, whose 2015 letter, 'Our Common Home' (Laudato Si'), see here, described a holistic vision for a sustainable planet and for humanity, echoing the spirt of St Francis of Assisi.

The Global Foundation strongly supports this ecological vision and the fair and just transition that needs to accompany this step-change in human affairs. For some time we have been in discussions with several of our key supporters to

see if it might be possible to make positive steps, via our roundtable meeting, to further enhance Assisi's global role as a city of integral ecology, on an ongoing and enduring basis.

The primary focus of the agenda in Assisi will be for an *Assisi Accord*, a statement of intent, advocacy and action, whose principal focus will be to help mobilise global investor capital to address climate change. The international financial sector has both the willingness and capability to make a huge difference in addressing climate change, but needs better tools and systems to make this more possible, at scale and with the speed required.

What is missing to make all of this possible is the present adequacy of the international financial system to account for, measure and mobilise the scale of private climate investment required, if we are to avoid a planetary meltdown.

The draft text for the Assisi Accord will be circulated well in advance to all who are participating, to allow for comment and feedback





and, for those who are in a position to do so, to make commitments to support, through advocacy and adoption.

It may also be that, through the efforts of a number of our supporters and their own growing networks, Assisi can play an enduring role, as a beacon to the world at large and as an inspirational meeting place and training centre, for those who wish to be better skilled in turning good intentions about integral ecology and the application of sustainable finance into practical reality.

The Rome Roundtable, 2016

Rome - what can we agree to do, to help to fix a broken world order?

We will continue our roundtable discussions in Rome, on Monday 23 May, commencing at 9:00am and running through the full day, before a break and then regrouping for a closing dinner, which is likely to conclude by 10:30pm.

Against a backdrop of an increasingly fractured world order, the roundtable discussions in Rome will address the broken world order that we are experiencing.

Just as Assisi will have set the tone for the requisite reform of the international financial system, in Rome we will incorporate this subject, as part of a wider assessment of a failing international order. We will consider what might usefully be done, beyond the wringing of hands, to improve, rebuild, international cooperation and governance.

As with the earlier focus on integral ecology, we will not be starting from scratch, rather building upon the outstanding leadership of those active in the space of international governance reform. The Foundation expresses its gratitude to

Mr. Pascal Lamy, one of the foremost exponents of international cooperation reform through his multiple roles, notable as the current President of the Paris Peace Forum <u>see here</u> and as former Director General of the World Trade Organisation.

Pascal Lamy is assisting the Foundation in the preparation of the Rome leg of the Roundtable and he will be joined by other global figures, including Archbishop Paul Gallagher, Vatican Secretary for Relations with Foreign States and Rt Hon Helen Clark ONZ SSI PC, former Prime Minister of New Zealand and former Administrator of the United Nations Development Program (TBC).
