Mr Ridwansyah Yusuf Achmad,

West Java Development Acceleration Team

Ridwansyah Yusuf Achmad is the Advisor on International Relations to the Governor of the Province of West Java and Chairs the West Java Development Acceleration Team’s Executive Board on Innovative Financing and Strategic Partnerships. Yusuf is also part of the West Java PPP (Public Private Partnership) Node, an entity established by Governor Ridwan Kamil as the first sub-National PPP unit in Indonesia . Besides PPP, Yusuf is also involved in the Province’s Municipal Bond process, the Corporate Social Responsibility (CSR) Forum and holds other investor related responsibilities. West Java currently has an ambitious EUR 80.000,000,000 infrastructure development program, most of which the Province plans to fund from non-government budget. Yusuf trained as an urban planner at Institut Teknologi Bandung and has earned a Master’s degree in Governance, Policy and Political Economy from Erasmus University Rotterdam.

Pavina Adunratanasee’s work has been focused at the intersection of clean energy financing and technology innovation. Dean, Faculty of Social Sciences, Pontifical University of St. Thomas, Rome, Italy

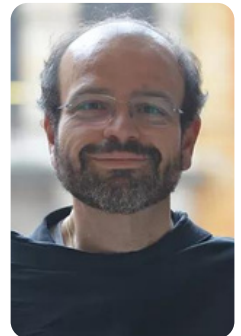

Sr. Alford graduated in manufacturing engineering from the University of Cambridge, where she was also awarded a PhD. She has served as consultant to the Pontifical Council for Justice and Peace. She is currently vice rector of the Pontifical University of Saint Thomas Aquinas in Rome. She is the author of numerous publications on management theory and corporate social responsibility. Sr. Helen is a consultant to the Dicastery for the Promotion of Integral Human Development in the Vatican as well as an ordinary member of the Pontifical Academy of Social Sciences. She was confirmed as the Angelicum's Dean of the Faculty of Social Sciences in 2021 and assists with many projects, including the new joint initiative with the Gregorian University, "Safeguarding: Mission and Commitment of the Church."



Fr. Paolo Benanti

Extraordinary Professor, Faculty of Theology, Department of Moral Theology, Pontifical Gregorian University, Rome

Fr. Paolo Benanti is a Franciscan of the Third Order Regular - TOR - and deals with ethics, bioethics and ethics of technologies. In particular, his studies focus on innovation management: internet and the impact of the Digital Age, biotechnologies for human improvement and biosecurity, neuroscience and neurotechnology. At the Pontifical Gregorian University he obtained a licentiate in 2008 and a doctorate in moral theology in 2012. The doctoral dissertation entitled "The Cyborg. Body and corporeality in the posthuman era" won the Belarmino Prize - Vedovato.



Since 2008 he has been a lecturer at the Pontifical Gregorian University, the Theological Institute of Assisi and the Pontifical Leonian College in Anagni. In addition to the institutional courses of sexual morality and bioethics, he deals with neuroethics, technology ethics, artificial and posthuman intelligence. He was part of the Artificial Intelligence Task Force to assist the Agency for Digital Italy. He is a corresponding member of the Pontifical Academy for Life with a particular mandate for the world of artificial intelligences. At the end of 2018 he was selected by the Ministry of Economic Development as a member of the group of thirty experts who at national level have the task of developing the national strategy on artificial intelligence and the national strategy on technologies based on shared ledgers and blockchain.

Dr. Claudio Mario Betti

Director, Australian Catholic University, Rome, Italy

Dr. Betti has held the position of Director of the Australian Catholic University Campus in Rome since 2015. Prior to this he was the Visiting Professor for the Master in Conflict Resolution and Peace Management at the Pontificia Facoltà Teologica San Bonaventura - Europa 2000, between 2005 and 2019. Dr Betti was also adjunct professor of International Relations and Conflict Resolution at the IES University in Rome between 2011-2015.

Dr. Betti has significant experience advising the Ministry of Health on international issues as well as advising the Minister of Integration and International Cooperation. He was advisor to the Board of the Fetzer Institute in Michigan and coordinator for 6 advisory groups of the Institute coordinating and leading scholars, politicians and practitioners of various disciplines between 2009-2013. Prior to this he was President of the Foundation for Assistance to Minors. Dr Betti is regularly invited as an international speaker and holds a PhD and a Post-Doctoral Degree in Contemporary History as well as a Master Degree in Italian Language & Literature.

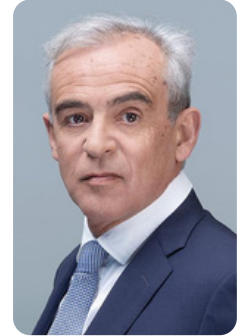


Mr Pascal Blanqué (TBC)

Chairman, The Amundi Institute

Pascal Blanqué has been Chairman of the Amundi Institute since February 2022. Previous to that, he was Group Chief Investment Officer and Head of the investment management platforms since 2005. He was also Global Head of Institutional Business and Third Party Distributors from 2010 to 2017. Pascal joined the Crédit Agricole group in 2000 as Chief Economist. Prior to joining Crédit Agricole, Pascal was Deputy Director of Economic Research at Paribas (1997-2000) following four years in the strategic asset allocation department of Paribas Asset Management in London (1992-1996). He began his career in institutional and private wealth management at Paribas in 1991.

As an economist and historian, Pascal is the author of several contributions. His research interests and his academic work focus on monetary issues, the functioning of financial markets and economic philosophy. He is a member of various think tanks such as the "Société d'Economie politique" and the 300 Club, as well as the MSCI Advisory Council and Bretton Woods Committee. Pascal was awarded European CIO of the Year 2013, 2018 and 2021 by Funds Europe Magazine and received the Institutional Investor Manager Lifetime Achievement Award in 2016. His book 10 weeks into Covid 19 - Psyche, Money, Narratives – an interpretation of the crisis was awarded the Turgot Financial Economy prize in 2022. Pascal studied at the Ecole Normale Supérieure. He is a graduate of Institut d'Etudes Politiques and holds a PhD in Finance from Paris-Dauphine University.



Mr Dennis Bracy

Chairman and CEO, Avatar Dimension; former CEO of US-China Clean Energy Council'

Chief Executive Officer, US-China Clean Energy Forum Chairman and CEO, Avatar Dimension Chairman and CEO, Avatar Studios Dennis Bracy counts himself fortunate to hold several fascinating jobs simultaneously: spearheading the team organizing the US-China Clean Energy Forum, heading Avatar Studios, a media production company in the US and leading a new company, Avatar Dimension, which makes holograms in its new studio outside Washington, DC. Combining a long-time commitment to strengthening US-China relations and a passion for finding solutions to global energy and environmental issues, Bracy has led the US team for the US-China Clean Energy Forum (www.cleanenergyforum.org) since the inception of the organization in 2007.

Over the past 20 years, he has served as a key advisor to Senators, Governors and Members of Congress and is considered a leading strategist on political and public affairs issues. As Chairman and CEO of Avatar Dimension, he leads a team making holograms for use in entertainment, training and heritage preservation. Avatar Dimension's new studio is one of only two Microsoft-licensed studios in the US. As Chairman of Avatar Studios (www.avatar-studios.com), he heads a company that produces television programs, videos and websites for clients around the world. In the early 1990s, Bracy led the team that developed the first prime-time television co-produced by foreigners in China and he continues to produce several documentaries and videos in China every year. His previous professional positions include president of Hill & Knowlton Technology, vice president of Kaiser Aluminium & Chemical Corporation, and press secretary for the Watergate trials.



Mr Tony Burdon

CEO, Make My Money Matter

Tony Burdon is the CEO of Make My Money Matter, a campaign to give people more voice and choice around how their money is invested and to ensure it is invested sustainably and responsibly. He has worked in international development for most of his life, spending over fifteen years living and working in Africa and Asia.

His first job was as a VSO volunteer water engineer working for the Government of Malawi. He worked for ten years in Oxfam, first as a humanitarian engineer, working in war and drought affected countries,



then leading Oxfam's work in Uganda and the humanitarian response to the Rwandan genocide, and finally as a policy advisor working on international financial institutions and debt relief, including representing Oxfam on the Board of Jubilee 2000, the successful debt relief campaign.

He then joined the UK civil service, working first in Treasury's International Poverty Reduction Team, and in the Commission for Africa, before moving to the Department for International Development. He led DFID's economic work in Nepal and Nigeria, and then as a senior civil servant led the Economic Growth, Private Sector and International Financial Institutions Departments. A considerable part of that time was concentrated on the mobilisation of private sector investment into developing countries, with a focus on impact, tackling the climate emergency, and achievement of the Sustainable Development Goals. It was during this time that Tony worked on early ideas around the Make My Money Matter campaign, leaving the civil service to head up the campaign at the start of 2020.

Ms Shiva Lynn Burgos

Contemporary Artist, Founder of The Mariwai Project

Shiva Lynn Burgos is a contemporary artist and photographer from New York currently living and working between Paris, London and Papua New Guinea. Her diverse contemporary, conceptual and collaborative practice is positioned within the unifying concepts of evolution, competition, natural and social selection. Burgos' works encompass photography, film, 360 Virtual Reality, sculpture, installation, painting, drawing, tapestry and performance as well as an ongoing passion for experimental and digital image making.

Shiva Lynn Burgos is the first international contemporary artist to work in Mariwai, a small Kwoma village located on the Upper Sepik River, Papua New Guinea. She has returned annually following her first trip there in 2013 and has created The Mariwai Project, an arts project and cultural exchange with the indigenous artists to include philanthropic support for art, culture, health, education and sustainable development in the region.

Burgos integrates field-collected and found objects with contemporary materials as a resource for examining value systems in relation to currency, spirituality and custom. The artist bridges her knowledge of this living culture with authorities in the field of anthropology, museum collections, government agencies and art market experts who define the value systems for tribal and indigenous art in order to recognize these communities and cultures within the greater international consciousness and due position within contemporary art. Dino Patti Djalal was born in Belgrade, Yugoslavia on 10th September 1965. He earned his Bachelor's Degree in Political Science from Carleton University (Ottawa, Canada); a Masters Degree in Political Science from Simon Fraser University (Vancouver, Canada), and a Phd in International Relations from the London School of Economics and Political Science (London, UK).



In 2004, Dino was appointed Special Staff of the President for International Affairs. In that capacity, Dino assumed many roles: Presidential spokesperson, foreign policy adviser to the President, speech writer.

From 2010 to 2013, Dino served as Indonesia's ambassador to the United States. In 2012, Dr. Dino won the prestigious "Marketeer of the Year", the same award that was won by President Joko Widodo. In June 2014, Dino was appointed Vice Minister for Foreign Affairs, until October that year. In 2015, he has founded the Foreign Policy Community of Indonesia.

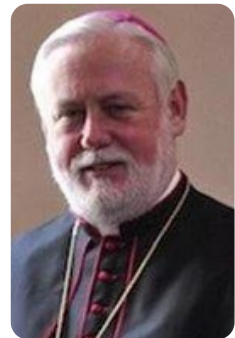
H.E. Archbishop Paul R. Gallagher

Secretary for Relations with States, The Holy See

Born in Liverpool, UK in 1954. Ordained a priest for the Archdiocese of Liverpool in 1977. Having gained a doctorate in Canon Law, he entered the diplomatic service of the Holy See in 1984, serving in the Apostolic Nunciatures in Tanzania (1984-1988), Uruguay (1988-1991), the Philippines (1991-1995) and subsequently as an official of the Section for Relations with States of the Secretariat of State (1995-2000).

He was appointed Special Envoy and Permanent Observer of the Holy See to the Council of Europe at Strasburg in 2000.

On 22 January 2004, he was appointed titular Archbishop of Hodelm and Apostolic Nuncio to Burundi and later that year he was ordained a bishop. After 5 years of service as Apostolic Nuncio in Burundi, he was appointed Apostolic Nuncio to Guatemala in 2009. On 11 December 2012, he was appointed Apostolic Nuncio to Australia. He was appointed to the post of Secretary for Relations with States on 8 November 2014.



Professor Dr. Enrico Giovannini

Ministry of Sustainable Infrastructures & Mobility in the Government of Italy

Appointed Minister on 13 February 2021. Economist, statistician and academic full professor (on leave) of economic statistics at the University of Rome "Tor Vergata", where he taught Statistics and Analysis and Policies for Sustainable Development. Chief Statistician of the OECD from 2001 to August 2009. President of ISTAT from August 2009 to April 2013. Minister of Labour and Social Policies from 2013 to 2014. He is the co-founder of the Italian Alliance for Sustainable Development (ASviS), a network of more than 290 subjects of Italian civil society, of which he was spokesperson until 13 February 2021. Until January 2021 he was President of the European Statistical Governance Advisory Board, member of the Executive Board of the Club of Rome, of the Global Happiness Council, Chairman of the Committee for the Report on the Economy Not Observed and Tax Evasion of the Ministry of Economy and Finance and member of the Scientific Committee of the Parliamentary Budget Office. From May 2020 he is responsible for the Futura Network project.

Gerbrand is responsible for the direction and daily operations of the World Benchmarking Alliance. Mr Steve Howard

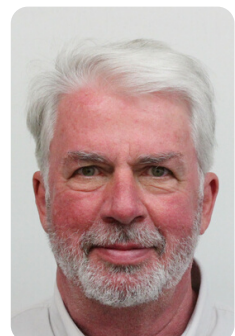
Secretary General, The Global Foundation

As founding Secretary General of the non-profit Global Foundation since 1998, Steve Howard has led the necessary global push for the adoption of 'co-operative globalisation', a holistic and long-term strategy to enable a sustainable global common good.

Much of Steve's work with the Global Foundation has involved aligning leaders from the private sector, civil society, academia, faiths and institutions, and sometimes from governments, from across the world, in defining and striving for a shared global vision, backed up by concrete actions.

Many world leaders, including Pope Francis and his most senior officials at the Vatican, have personally participated in and endorsed this and related initiatives. Prior to the Global Foundation, he led the successful renaissance strategy for Melbourne, Australia in the early 1990's, including a national strategy to enable private sector investment in public infrastructure, which has since been adopted as investment model, worldwide.

Through his own firm, he has nationally and internationally won more than 20 competitions and awards.



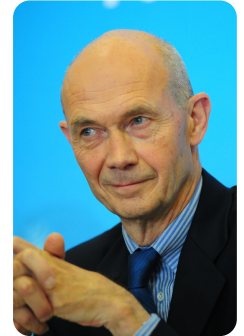
Mr Pascal Lamy

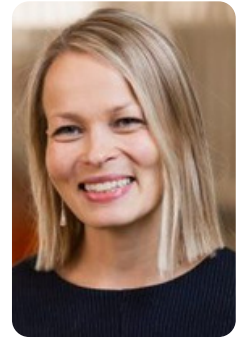

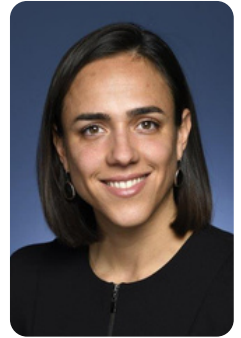
H.E. Ambassador Chiara Porro

He was previously Director of Development at the French Ministry of Cooperation, Vice-President for East Asia at the World Bank, and Director General of the French Development Agency (AFD) from 2001 to 2010. He is a lead director of the board of Danone, a chairman of its governance committee, as well as a director of Orange and Michelin. He chairs Veolia's "critical friends committee". He has been a member of the boards of directors of EIB and Ecobank International, as well as of several corporate foundations (Carrefour, Sanofi, Alstom, Avril).

Sister Alessandra Smerilli works at the Pontifical Faculty of Educational Sciences Auxilium as an extraordinary professor of political economy and statistics, and also as a member of the University's board of directors. She also teaches economics, ethics and finance at the Faculty of Philosophy of the Salesian Pontifical University and in the master's program in civil and non-profit economics at the University of Milan-Bicocca. She is a member of the Scientific and Organizational committees of the Social Weeks of Italian Catholics, and since 2013 the Secretary of this initiative.

In 2019, Pope Francis appointed Sr. Smerilli as a councilor of the Vatican City State. On 24 March 2021, Pope Francis appointed her the Undersecretary for the Faith and Development Sector of the Dicastery for Promoting Integral Human Development of the Roman Curia. On 23 April 2022 Sr. Smerilli became the Secretary for the Dicastery.



Bishop Domenico Sorrentino (TBC)

Archbishop of Foligno & Bishop of Assisi-Nocera Umbra Gualdo Tadino, Italy

Bishop Domenico Sorrentino was ordained a Catholic priest for the Diocese of Nola in 1972, having studied at the Roman ecclesiastical universities as a pupil of the Almo Collegio Capranica. Sorrentino then obtained a doctorate in theology from the Pontifical Gregorian University in Rome and a doctorate in political science from the University of Rome La Sapienza.

After a number of appointments in his home diocese, he was appointed to diocesan responsibilities for catechetics. He was also involved in the establishment of a library centred on the figure of the church father, Paulinus of Nola. 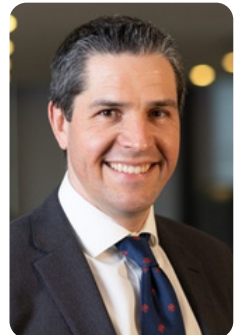


Mr Tom Tayler

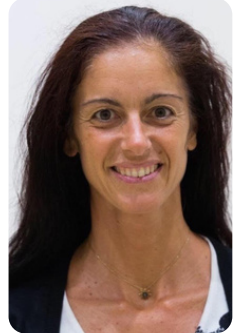
