Mr Steve Howard Secretary General, The Global Foundation

As Founding Secretary General of the non-profit Global Foundation since 1998, Steve Howard has led the necessary global push for the adoption of 'co-operative globalisation', a positive strategy for inclusive, 'win-win' economic development and a sustainable global economy.

Many world leaders have personally participated in and endorsed this and related initiatives.

Through this collaborative and low-key approach, Steve has helped to shape global affairs with practical outcomes over more than 20 years.

Prior to the Global Foundation, he led the successful renaissance strategy for Melbourne, in Australia in the 1990's, including a national strategy for private sector investment in public infrastructure, now adopted as a business model, worldwide.

Louise has been a member of the Board of the Global Foundation since 2017. She has over 25 years' experience as a strategic adviser to companies and Government. Louise has long-standing and trusted relationships with Australia's corporate leaders, influencers, investors, market operatives, and the media.

In 2002, Louise established Symbol Strategic Communications, recognised as one of Australia's leading corporate advisory firms in communications and investor relations. Louise advises leaders and companies on seminal events and issues, significant

transactions and transformation projects, and during times of corporate change.

Louise has two decades of diverse Board experience and is currently also a Non-Executive Director of the Brandenburg Foundation. Previously, Louise was a Non-Executive Director of CARE Australia; an Advisory Board Member of Grant Samuel and Associates; a Non-Executive Director of the Odyssey House McGrath Foundation and a Committee member of the Prime Minister's Supermarket to Asia Council Communications Working Group.

Sue Kench is the Global Chief Executive of King & Wood Mallesons. She leads the development and implementation of the firm's international growth strategy and is responsible for integrating the firm's international operations.

Together with the Global Chairman, Sue oversees the firm's International Management Committee and the Global Executive team which are responsible for setting the firm's strategic priorities and international business plans.

Sue has a reputation for driving positive change, aligning and engaging diverse groups around a

Her leadership was recognised by the Financial Times when she received the 'Australian innovative leader award' at the FT Asia Pacific Innovative Law Firm awards in 2018. She was also named in the 2018 Australian Financial Review's 100 Women of Influence.

Sue was appointed Global Chief Executive in 2017 following four years as Chief Executive Partner Australia where she led a very successful growth agenda.

Jean-Jacques Barbéris is General Management and Executive board member at Amundi. Jean-Jacques is head of Institutional and Corporate Clients Coverage and supervises the ESG department. Jean-Jacques is also chairman of Amundi Germany and of CPR asset management.

Before joining Amundi, Jean-Jacques acted as advisor for Economic and Financial affairs in the staff of the French President of the Republic, where he served from 2013-2016. Prior to this, he was a member of staff of Pierre Moscovici, French Minister of Economy and Finance.

Between 2009 and 2010, Jean-Jacques chaired the European group of experts on climate finance in the negotiations at UNFCCC. During that time, he also participated in different studies on the economics of climate change, such as Jean Tirole's report published before the Copenhagen UNFCC conference in 2015.

Jean-Jacques started his career in the French Treasury Directorate General where he served from 2008 to 2012.

Jean-Jacques was a lecturer in advanced economics at Sciences-Po Paris From 2009 to 2012. He is also chairman of the French think tank "En Temps Réel", dedicated to European politics.

Jean-Jacques is a Young Global Leader of the World Economic Forum since 2019.

He is also a vice-chairman of Finance for Tomorrow, the French financial association devoted to sustainable finance.

Jean-Jacques Barbéris graduated from Ecole Normale Supérieure "Lettres et Sciences Humaines", "agrégé" in History, and alumni at both Sciences Po Paris and Ecole Normale d'Administration.



Dr. Mark Cutifani

Chief Executive Officer, Anglo American

Mark Cutifani, FEng CEng FIMMM FAusIMM DBA (Hon) DoL (Hon) BE (Mining-Hons), was appointed Chief Executive of Anglo American Plc on 3 April 2013.

He is a qualified mining engineer with more than 40 years of broad experience of projects, operations, marketing, business development and finance. Mark is also the Chairman of De Beers Group of Companies, a non-executive director of Total SA, and a non-Executive Director of Anglo American Platinum Limited.

Mark has considerable experience in mining, having

been associated with the industry since 1976 and has a practical working knowledge of most of the commodities produced and sold across the globe. He has had line experience and responsibility for mining and industrial businesses across six continents.

Prior to joining Anglo American, he held the position of Chief Executive Officer at AngloGold Ashanti based in South Africa, and before that he was the Chief Operating Officer for Inco and then Vale's global Nickel business, based in Canada.



Dr. Philip Lowe

Governor of the Reserve Bank of Australia

Philip Lowe is Governor of the Reserve Bank of Australia. Mr Lowe holds a PhD from the Massachusetts Institute of Technology and a B.Comm (Honours) in Economics/Econometrics from the University of New South Wales. He has authored numerous papers, including on the linkages between monetary policy and financial stability. He commenced as Governor on 18 September 2016.

He is Chair of the Reserve Bank Board and Payments System Board, and Chair of the Council of Financial Regulators. He is a member of the Financial Stability

Board. Prior to his current role, he held the positions of Deputy Governor, Assistant Governor (Economic) and Assistant Governor (Financial System). He also spent two years at the Bank for International Settlements working on financial stability issues.

Mr Lowe is Chair of the Financial Markets Foundation for Children and a director of The Anika Foundation. He is also Chair of the Committee on the Global Financial System of the Bank for International Settlements. Mr Lowe is a signatory to The Banking and Finance Oath.



Prof. Sir Edward Byrne AC
Chairman of the Australian Advisory Council, the Global Foundation

Professor Sir Edward Byrne AC is a world leading neuro-scientist and has recently completed his seven year tenure as President & Principal of King's College, London.

Previously Professor Byrne was Vice Chancellor of Monash University and recently returned to Australia, to a portfolio including Global Chief Medical Officer for Ramsay Health Care and Chair of the Australian Advisory Council of the Global Foundation.

Professor Byrne was a founding director of the Melbourne Neuromuscular Research Unit and the Centre for Neuroscience in 1993. He was made Professor of Experimental Neurology at the University of Melbourne in 2001.

His major research contributions have been in the field of mitochondrial medicine and neuromuscular disorders. Professor Byrne was also appointed the Vice Provost (Health) at University College London (UCL).



Ms. Jane Halton AO PSM
Chair of the Coalition for Epidemic Preparedness & Innovations & Cochair of the COVAX Initiative

Jane Halton is a member of the board of the ANZ Bank, Clayton Utz, the Australian Strategic Policy Institute, and the US Institute of Health Metrics and Evaluation. She is chairman of the Coalition for Epidemic Preparedness Innovations, COTA, and Vault Systems.

Her 33-year career in the Australian public service included nearly 15 years as Secretary of the Department of Finance and Secretary of the Department of Health and Ageing.

Previously, she was Executive Co-ordinator (Deputy Secretary) of the Department of the Prime Minister and Cabinet. She has extensive experience in health policy and delivery, the delivery of the Australian government budget, and the management and performance of Australian government agencies.

Ms. Halton has held a number of significant roles in global health governance, including as chair of the board of the World Health Organization (WHO), president of the World Health Assembly, and chair of the Organisation for Economic Co-operation and Development (OECD) health committee.



Prof. Patricia Davidson
Vice Chancellor, University of Wollongong

Professor Patricia M. Davidson joined the University of Wollongong as Vice-Chancellor in May 2021. Professor Davidson was previously Dean of the Johns Hopkins School of Nursing in Baltimore, United States. In 2021 she was the recipient of the Consortium of Universities for Global Health (CUGH) Distinguished Leader Award.

As a global leader in nursing, health care, and advocacy, Professor Davidson's work focuses on person-centred care delivery and the improvement of cardiovascular health outcomes for women and

vulnerable populations.

Professor Davidson serves as counsel general of the International Council on Women's Health Issues, and was a past board member of CUGH and secretary general of the Secretariat of the World Health Organizations Collaborating Centres for Nursing and Midwifery.

She also serves on the Board of Health Care Services for the National Academies of Sciences, Engineering, and Medicine in the United States.



Rev. Tim Costello AO
Spokesman, End COVID For All

Reverend Tim Costello AO is one of Australia's most respected community leaders, renowned for ensuring the challenges of global poverty are firmly and consistently on the national agenda. Rev. Costello is currently the spokesman for End Covid For All which focuses on Australia's role in vaccinating the world against Covid-19.

The Director of Ethical Voice, and Executive Director of Micah Australia, Tim was Chief Executive of World Vision Australia (WVA) for 13 years until October

2016, after which he became WVA's Chief Advocate for two years. Other positions Tim holds are Senior Advisor for the Centre for Public Christianity, Chair of the Community Council of Australia; Chief Advocate of the Thriving Communities Partnership.

Tim is a spokesperson for the Alliance for Gambling Reform, which advocates for law reform to prevent harm from poker machine gambling. Tim Costello is a sought-after voice on social justice issues, leadership and ethics.



Dr. Keith Martin MD PC
Foundation Executive Director of the Consortium of Universities for Global Health

Dr. Martin is a physician who, since September 2012, has served as the founding Executive Director of the Consortium of Universities for Global Health (CUGH). Between 1993-2011, Dr. Martin served as a Member of Parliament in Canada's House of Commons. He held portfolios in foreign affairs, health, the environment, defence and international development.

He has been on many diplomatic missions in areas in crisis around the world but particularly across Africa and worked as a physician on the Mozambique border during their civil war. He has spent many years volunteering on conservation efforts in South Africa and is a member of the Queen's Privy Council for Canada.



Dr. Steve Waygood
Chief Responsible Investment Officer, Aviva Investors

Steve has always been fascinated by the power of money to change the world. He has worked for Aviva Investors for the last 15 years where he founded its Global Responsible Investment team as well as its Sustainable Finance Centre for Excellence, which seeks to transform capital markets so that they become more sustainable. He also co-founded the Corporate Human Rights Benchmark, the World Benchmarking Alliance, and the UN Sustainable Stock Exchange Initiative.

Steve was appointed to the European Commission High-Level Expert Group on Sustainable Finance, and the UK Green Finance Taskforce, and is also a member of the Financial Stability Board Taskforce on Climate Related Financial Disclosure (TCFD). He was highlighted by the Financial Times in 2018 as being one of the warriors of climate change among Money Managers.



Steve started his career at WWF-UK in 1995, where he worked on its own ethical and environmental investment policy. He has subsequently advised the UK Government, the European Commission, the Financial Stability Board and the UN on the creation of sustainable capital markets.

His work became a case study in the Harvard Business School MBA in 2012. Steve has received the Leadership in Sustainability award from the Corporation of London and the British Chamber of Commerce.

The Hon. Mathias Cormann
Secretary General, OECD

Mathias Cormann is the 6th Secretary-General of the Organisation for Economic Co-operation and Development (OECD). His five-year term commenced on 1 June 2021.

Mathias was born and raised in the German-speaking part of Belgium. Before migrating to Perth, Australia, Mathias had graduated in law at the Flemish Catholic University of Louvain (Leuven), following studies at the University of Namur and, as part of the European Erasmus Student Exchange Program, at the University of East Anglia.



Prior to his appointment to the OECD, Mathias served as the Australian Minister for Finance, the Leader of the Government in the Australian Senate and as Federal Senator representing the State of Western Australia. In these roles, he has been a strong advocate for the positive power of open markets, free trade and the importance of a rules-based international trading system.

Between 1997 and 2003, he worked as Chief of Staff as well as Senior Adviser to various State and Federal Ministers in Australia and for the Premier of Western Australia.

Professor Dr. Enrico Giovannini
Ministry of Sustainable Infrastructures and Mobility in the Government of Italy

Appointed Minister on 13 February 2021. Economist, statistician and academic. Full professor (on leave) of economic statistics at the University of Rome "Tor Vergata", where he taught Statistics and Analysis and Policies for Sustainable Development. Chief Statistician of the OECD from 2001 to August 2009. President of ISTAT from August 2009 to April 2013. Minister of Labour and Social Policies from 2013 to 2014. He is the co-founder of the Italian Alliance for Sustainable Development (ASviS), a network of more than 290 subjects of Italian civil society, of which he was

spokeperson until 13 February 2021.

Until January 2021 he was President of the European Statistical Governance Advisory Board, member of the Executive Board of the Club of Rome, of the Global Happiness Council, Chairman of the Committee for the Report on the Economy Not Observed and Tax Evasion of the Ministry of Economy and Finance and member of the Scientific Committee of the Parliamentary Budget Office. From May 2020 he is responsible for the Futura Network project.



Professor Dr. Stefania Proietti Ph.D Mayor of Assisi & President of the Province of Perugia, Italy

Stefania Proietti was first elected Mayor of Assisi, Italy, in June 2016 and has just recently been re-elected in October 2021.

She has a distinguished academic and corporate background, with a doctorate in mechanical engineering and is renowned globally for her work on climate action and carbon markets, at academic, political and business levels.

Mayor Proietti participated in the Foundation's 2018 Rome Roundtable and has invited the Foundation to partner with her for the presentation of the 'Economy of Francesco' global conference, featuring Pope Francis and 3,000 young entrepreneurs, to be held in Assisi from 26-28 March 2020.

In addition, she will host the Global Foundation during the visit to Assisi in May 2021 in association with its Rome Roundtable.



Mr. Pascal Lamy President, Paris Peace Forum & Former Director General of the World Trade Organisation

Pascal Lamy (pascallamy.eu) is the President of the Paris Peace Forum and of the European branch of the Brunswick Group. He coordinates the Jacques Delors Institutes (Paris, Berlin, Brussels).

He is also President or member of various boards with a global, european or french vocation (European Starfish Mission (ocean), Mo Ibrahim Foundation, European Climate Foundation, IFPRI, PECC, CERRE, TMEA, Antarctica 2020, Transparency International, Alpbach Forum, Beijing Forum, World Trade Forum, WEF, Global Risks, Europaeum, Collegium international, Musiciens du Louvre, Institut Mendes-France, Colbert Foundation, etc.).

He is an affiliated professor at the China Europe International Business School CEIBS (Shanghai) and at HEC (Paris).

From 2005 to 2013, Pascal Lamy served two consecutive terms as Director General of the World Trade Organization (WTO). He was previously Trade Commissioner (1999-2004), Director General of Crédit Lyonnais (1994-1999), Chief of Staff of the President of the European Commission, Jacques Delors and his G7 Sherpa (1985-1994), Deputy Chief of Staff of the French Prime Minister (1983-1985) and to the French Minister of the Economy and Finance (1981-1983). Last publication "Strange new world" (Odile Jacob 2020), "Où va le monde?" (Odile Jacob 2018).



The Right Hon. Helen Clark ONZ SSI PC Former Prime Minister of NZ & Former Administrator of the United Nations Development Programme

Helen Clark is a respected global leader on sustainable development, gender equality and international co-operation. She served three successive terms as Prime Minister of New Zealand between 1999 and 2008.

While in government, she led policy debate on a wide range of economic, social, environmental and cultural issues, including sustainability and climate change.

She then became the United Nations Development

Programme (UNDP) Administrator for two terms from 2009 to 2017, the first woman to lead the organisation.

She was also the Chair of the United Nations Development Group, a committee consisting of the Heads of all UN funds, programmes and departments working on development issues.

In 2019 Helen Clark became patron of The Helen Clark Foundation. She is an active member of many global organisations.



Dr Dino Patti Djalal Founder, Foreign Policy Community of Indonesia and Former Deputy Foreign Minister, Republic of Indonesia

Dino Patti Djalal was born in Belgrade, Yugoslavia on 10th September 1965. He earned his Bachelor's Degree in Political Science from Carleton University (Ottawa, Canada); a Masters Degree in Political Science from Simon Fraser University (Vancouver, Canada), and a Phd in International Relations from the London School of Economics and Political Science (London, UK).

In 2004, Dino was appointed Special Staff of the President for International Affairs. In that capacity, Dino assumed many roles: Presidential spokesperson,

foreign policy adviser to the President, speech writer. From 2010 to 2013, Dino served as Indonesia's ambassador to the United States.

In 2012, Dr. Dino won the prestigious "Marketeer of the Year", the same award that was won by President Joko Widodo.

In June 2014, Dino was appointed Vice Minister for Foreign Affairs, until October that year. In 2015, he has founded the Foreign Policy Community of Indonesia.



Dr. Da Wei

Director of the Centre for International Security and Strategy (CISS), Professor of Department of International Relations, School of Social Science

Dr. Da Wei is Director of the Center for International Security and Strategy (CISS) at Tsinghua, and Professor of the Department of International Relations, School of Social Science, Tsinghua University. Dr. Da 's research expertise covers China-US relations and US security & foreign policy.

Da Wei has worked in China's academic and policy community for more than 2 decades. Prior to current positions, Dr. Da Wei was the Assistant President of University of International Relations (2017-2020),

Director of the Institute of American Studies, China Institutes of Contemporary International Relations (2013-2017).

He has written hundreds of policy papers to Chinese government, and published dozens of academic papers on journals in China, the US and other countries. Da Wei earned his BA and MA from UIR, and his Ph.D. from CICIR. He was a visiting senior fellow at the Atlantic Council of the United States from 2006 to 2007, and a visiting senior associate at SAIS, Johns Hopkins University from 2008 to 2009.

Head of Research & Design, 12th Level

Kate Burke is a social researcher and design strategist with a background in science communication and the arts. As Head of Research & Design at software engineering and design company 12thLevel, Kate is a research strategist who loves to find points of connection and common ground in peoples' stories and innovate for positive change.

As a science communicator, Kate has appeared as a regular on ABC radio, helped to shape the Young Rural Scientist of the Year Award, and worked as a freelance science journalist with a focus on regional issues. She has also worked as a community consultant and is a professional musician and music producer.



Ms. Pauliina Murphy

Engagement Director, World Benchmarking Alliance

Pauliina leads the WBA's advocacy and outreach strategy for the WBA and its benchmarks, building and strengthening relationships with diverse stakeholders, including investors, civil society and governments, working to ensure that the Alliance is inclusive and relevant globally.

Pauliina joined the WBA from Aviva, a global insurance company and asset manager, where she was Head of International Government Engagement.

At Aviva, Pauliina drove forward international policy development and advocacy campaigns on sustainable finance and trade and investment, working closely with multi-lateral institutions such as the UN, G7 and G20.

Pauliina ran the company's global stakeholder and political engagement strategy, to change the rules at the highest level so that capital is deployed to drive sustainable growth.
