***Mobilising the global financial sector to address climate change: the 'Assisi Accord'***

Climate change may well be the greatest threat to global peace, security and stability facing humanity in the coming decades. It can only be properly addressed through universal action that crosses national and other borders. This requires an unprecedented level of co-operation and mobilisation, at a scale of action that is truly breath-taking. Yet much of the solution to this wicked problem could come from the private sector, in particular global investors who generally take a longer-range view. As a result, investors are not only calling for action, but also willing to play a leading role, in working with governments and communities to rise to the climate change challenge. The draft '**Assisi Accord**' is a call to action and it will be illuminated at this session, in the hope that those taking part in the roundtable and others with whom we are interacting, including the Vatican, will also wish to support and elevate this most pressing global problem to the forefront of international attention and action.

#### **9:00am Roundtable Session Three:**

***What's required to deliver the Assisi Accord and to ensure a just transition to a sustainable future?***

Understanding the scope of the challenge and the scale of investment that will be required is a fundamental starting point in the race to address climate change. At the same time, as more and better multilateralism is needed, the machinery of the international financial system that will facilitate this massive investment shift is no longer suitable for purpose. Calls for the fundamental reform of the Bretton Woods institutions, to take account of the realities of a changed world are, at last, growing louder and more coherent. Just recently, US Treasury Secretary, Janet Yellen added the voice of her Government to those of many emerging nations and multiple other actors. What would be required to make the climate change investment mega-shift possible and how would this be enacted? At the same time, how to ensure a just and fair global transition to a cleaner, greener future and does not, in fact, increase inequalities that are evident today and in some cases, growing?

Is it possible to propose to the His Holiness a leadership role in this regard and for us to offer our support to the renewal process that will surely take considerable time and effort?
