Zanny Minton Beddoes

Zanny Minton Beddoes is the Editor-in-Chief of The Economist. She is a renowned global economics expert, sought-after for her authoritative perspectives on the world economy. She previously worked at the IMF, and as an adviser to the Minister of Finance in Poland.



Jennifer Bouey

Dr. Jennifer Bouey is a senior policy researcher, Tang Chair for China Policy Studies, and an epidemiologist at the RAND Corporation. She also serves as the department chair for Global Health at Georgetown University and a professor of policy analysis at the Pardee RAND Graduate School. She leads wide-ranging collaborative research initiatives on the U.S.-China relationship, racial equity for Asian Americans, global health security, and health equity. Currently she is working on projects to assess the impact of China's overseas development, study public health and soft power, gender equity, and fertility, and coordinate U.S.-China Track II dialogues on climate and trade policies. During the COVID-19 pandemic, Bouey has testified multiple times before U.S. Congressional committees on China's public health, global health, and health care reforms. Bouey's work has been quoted in general interest publications such as The New York Times, The Washington Post, Financial Times, The Economist, and The Hill, as well as scholarly journals such as the American Journal of Public Health, Health Affairs, Emerging Infectious Diseases, and BMJ Open. Her research on infectious disease prevention among migrant population has been funded by NIH, HRSA/HHS, and multiple foundations. Bouey also has been a consultant to the World Bank Group, UNAIDS, USAID, Hong Kong Government AIDS Fund, and other international NGOs. She earned her Ph.D. and M.P.H. in epidemiology from The George Washington University, and her M.D. from Peking University.



CHHEM Kieth Rethy

Professor CHHEM Kieth Rethy is a medical doctor, science diplomat, educator and historian with extended experience in Digital Science & Technology, Global Health Diplomacy, Nuclear Technology Policy, and Executive Education. He was Professor of Radiology in Canada (McGill), Singapore (NUS), Austria and Japan (Hiroshima, Nagasaki, Fukushima Medical University) for 30 years. He was the Chair of the Radiology and Nuclear Medicine Department of University of Western Ontario. He was the Director of the Division of Human Health at the International Atomic Energy Agency (IAEA). He holds a MD, a PhD in Education and a PhD in History. He published more than 100 scientific articles and edited 17 textbooks. He was invited keynote speaker in more than 70 countries. Over the last 3 decades, he developed a deep expertise in international development, digital transformation, and nuclear science Communication. From 2014 to 2019, he was the Executive Director of the Cambodian Development Resource Institute (CDRI), a leading think tank in Cambodia, that ranked at the Top 100 of the University of Pennsylvania Global Think Tank ranking. He is also a member of Advisory Board of the International Center for Higher Education Innovation (UNESCO) at the Southern University of Science and Technology in Shenzhen. He is a distinguished visiting professor at the Atomic Bomb Disease Institute, Nagasaki, Hiroshima and Fukushima Medical University. He is a cofounder of China Studies Center at CDRI. He is an international advisor to the China Institute of International Studies in Beijing and a Senior Fellow at the Asia-Pacific Fellows Network of the East West Institute in New York City. In May 2019, Professor CHHEM Kieth Rethy was appointed by royal decree, Minister Delegate, Attached to the Prime Minister.



Chung Jae-Hung

Chung Jae-Hung is Director (Department of Security Strategy Studies & Center for Chinese Studies) of the Sejong institute in Korea. He received B.A. M.A. from Peking University in China (Beijing) and Ph.D. from Chinese Academy of Social Science in China (Beijing). He was an Assistant professor of Kyungnam University (2013-2015), the Institute of Far Eastern Studies (IFES) Analysis (2007-2013) and policy advisor Ministry of National Defence and NIS. He has served as Consulate General of the Republic of Korea Guangzhou in China, Senior Political Researcher (2010-2012). Main research interests include Chinese Security (Defence) and Chinese Non-traditional Security, Sino-North Korea (Sino-South Korea) Security (Defence) relations, Northeast Asian and Korean Peninsula Security (Defence) issue. Recently his research paper and writings include Recent China's Islamic Terrorism: Trend and Policy Considerations(2017), China-Pakistan-Iran Trilateral Security Cooperation(2018), The Third DPRK-PRC Summit: Seoul's Strategic Contemplation and Response(2018), China's Future Military Security Strategy in the Era of U.S.-China Competition (2020), U.S. Withdrawal from Afghanistan and Its Impact on Regional Security Environment(2021), The Taliban's return to power and China's influence(2021), The recent U.S.-China military security competition and the Taiwan Strait crisis (2021), Strategic Competitions among Russia, China and the US: War in Ukraine(2022) and so on.



Joseph DeTrani

Ambassador DeTrani is the former Director of the National Counterproliferation Center and the former Special Envoy for negotiations with North Korea and the U.S. representative to the Korea Energy Development Organization. He was an Associate Director of National Intelligence and senior adviser to the Director of National Intelligence. Prior to that, he was a member of the Senior Executive Service at the Central Intelligence Agency and an officer in the U.S. Air Force. Ambassador DeTrani was the president of Intelligence and National Security Alliance and the president of the Daniel Morgan Graduate School of National Security. He's a professor at Missouri State University's Graduate Department of Defense and Strategic Studies, an adviser at Sandia National Laboratories, a fellow at the Institute for Corean-American Studies and a member of the Council on Foreign Relations and the National Committee on North Korea. He is the recipient of numerous government awards and has published and spoken publicly about North Korea, China, East Asia and nuclear nonproliferation.



Dino Patti Djalal

Dr. Dino Patti Djalal is a retired career diplomat; former Presidential spokesperson, speech writer and special staff; former Indonesia' s Ambassador to the United States; youth activist; academic; author of a national best seller; talk show host, and former Vice Minister for Foreign Affairs (2014). Contrary to his own belief, Dino cannot sing and is a terrible cook. He is known in Indonesia as Presidential Spokesperson for President Susilo Bambang Yudhoyono – a position he held for 6 years from October 2004 to October 2010, which makes him the longest serving Presidential spokesperson in Indonesia's modern history.



Douglas Paal

Douglas H. Paal is a distinguished fellow at the Carnegie Endowment for International Peace. He previously served as vice chairman of JPMorgan Chase International (2006–2008) and was an unofficial U.S. representative to Taiwan as director of the American Institute in Taiwan (2002–2006). He was on the National Security Council staffs of Presidents Reagan and George H. W. Bush between 1986 and 1993 as director of Asian Affairs and then as senior director and special assistant to the president.

Paal held positions in the policy planning staff at the State Department, as a senior analyst for the CIA, and at U.S. embassies in Singapore and Beijing. He has spoken and published frequently on Asian affairs and national security issues.



Paul Gewirtz

Paul Gewirtz is the Potter Stewart Professor of Constitutional Law and also the Director of the Paul Tsai China Center at Yale Law School. He teaches and writes in various legal and policy fields, including constitutional law, the U.S. judicial system, U.S. foreign policy, Chinese law, and U.S.-China relations.

The Paul Tsai China Center, which Professor Gewirtz founded in 1999 as The China Law Center, focusses on Chinese law and U.S.-China relations, and is a leading institution in both fields. While on leave from Yale in 1997 and 1998, Professor Gewirtz served as Special Representative for the Presidential Rule of Law Initiative in President Bill Clinton's administration, where he developed and led the U.S.-China initiative to cooperate in the legal field that President Clinton and China's President Jiang Zemin agreed to at their 1997 and 1998 Summit meetings.

Gewirtz was also the founder and for 10 years the Director of Yale Law School's Global Constitutionalism Seminar, which brings leading Supreme Court judges from around the world to Yale each year. Before joining the Yale faculty, Gewirtz served as a Law Clerk to Justice Thurgood Marshall of the United States Supreme Court. He is a member of the Council on Foreign Relations. He received his B.A. degree summa cum laude from Columbia University and his law degree from Yale.



Stephen Hadley

Stephen Hadley is a principal of Rice, Hadley, Gates & Manuel LLC, an international strategic consulting firm founded with Condoleezza Rice, Robert Gates, and Anja Manuel. Mr. Hadley is also the former Board Chair of the United States Institute of Peace (USIP) and an Executive Vice Chair of the Board of Directors of the Atlantic Council.

Mr. Hadley served for four years as the Assistant to the President for National Security Affairs from 2005 to 2009. From 2001 to 2005, Mr. Hadley was the Assistant to the President and Deputy National Security Advisor, serving under then National Security Advisor Condoleezza Rice. Mr. Hadley had previously served on the National Security Council staff and in the Defense Department including as Assistant Secretary of Defense for International Security Policy from 1989 to 1993.

During his professional career, Mr. Hadley has served on a number of corporate and advisory boards, including: the National Security Advisory Panel to the Director of Central Intelligence, the Department of Defense Policy Board, and the State Department's Foreign Affairs policy Board. He is a member of the Aspen Strategy Group.



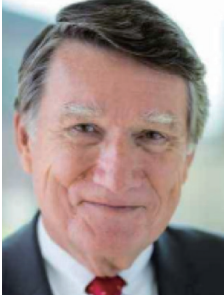
Paul Haenle

Paul Haenle holds the Maurice R. Greenberg Director's Chair at Carnegie China and is currently based in Singapore as a Visiting Senior Research Fellow at the East Asian Institute, National University of Singapore. In addition to his role at Carnegie, Haenle is also Asia Pacific Chairman, at the global CEO advisory firm Teneo. Since 2018, Haenle has served on the board of directors of the National Committee on U.S.-China Relations.

Prior to joining Carnegie, Haenle served as the White House China director on the National Security Council under former Presidents George W. Bush and Barack Obama. From June 2007 to January 2009, Haenle also played a key role as the White House representative to the U.S. negotiating team at the six-party-talks nuclear negotiations. Beginning in 2004, Haenle served three years in the West Wing as special assistant to U.S. National Security Advisors Condoleezza Rice and Stephen Hadley.

Trained as a China foreign area officer in the U.S. Army, Haenle has been assigned twice to the U.S. embassy in Beijing, served as a U.S. Army company commander during a two-year tour to the Republic of Korea, and worked in the Pentagon as an adviser on China, Taiwan, and Mongolia Affairs on the staff of the chairman of the Joint Chiefs of Staff. Early assignments in the U.S. Army included postings in Germany, Desert Storm, Korea, and Kuwait. He retired from the U.S. Army as a lieutenant colonel in October 2009.

Haenle received an M.A. in Asian studies from Harvard University, and a B.S. from Clarkson University.



John Holden

Mr. Holden's China career spans more than four decades, twenty-eight years of which he spent on the ground in Beijing, Hong Kong, and Taipei. Prior to joining McLarty in 2019, Holden served as President and CEO of the US-China Strong Foundation after a decade in Beijing as Managing Director and Senior Counselor for Hill+Knowlton Strategies; Founding Chairman of Shaklee (China) Ltd.; Associate Dean at Peking University's Yenching Academy and Professor of Practice at its Guanghua School of Management. While at Peking University, Holden received a national award for service to education as well as the country's Friendship Award.

From 1998 to 2005, Mr. Holden was President of the National Committee on United States–China Relations, where he created legacy programs such as the Public Intellectuals Program (PIP), the U.S.-China Young Leaders Forum, and the U.S.-China Foreign Policy Colloquium. For the twelve prior years, he was employed by Cargill, where he played key roles in the establishment the firm's first ten businesses in China and served as chairman of its China holding company.

Mr. Holden has been active in the American Chambers of Commerce in both Hong Kong and Beijing, and served as chairman of the Board of Governors of the latter organization in 1997. He is a member of the Council on Foreign Relations and the National Committee on U.S.-China Relations, and is Senior Associate (Non-resident) of the Trustee Chair in Chinese Business and Economics at the Center for Strategic and International Studies.

Also known by his Chinese name 何立强, Mr. Holden has a solid foundation in literary and Mandarin Chinese, which he studied at the University of Minnesota (BA magna cum laude) and Stanford University (MA and all PhD coursework).



Steve Howard

Secretary General, the Global Foundation

As founding Secretary General of the non-profit Global Foundation since 1998, Steve Howard has led the necessary global push for the adoption of 'co-operative globalisation', a holistic and long-term strategy to enable a sustainable global common good.

Much of Steve's work with the Global Foundation has involved aligning leaders from the private sector, civil society, academia, faiths and institutions, and sometimes from governments, from across the world, in defining and striving for a shared global vision, backed up by concrete actions.

Many world leaders, including Pope Francis and his most senior officials at the Vatican, have personally participated in and endorsed this and related initiatives. Through this collaborative and low-key approach, Steve and the Global Foundation have helped to shape global affairs with practical outcomes.

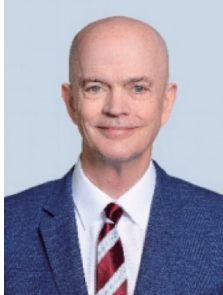

Scott Kennedy

Scott Kennedy is senior adviser and Trustee Chair in Chinese Business and Economics at the Center for Strategic and International Studies (CSIS). A leading authority on Chinese economic policy, Kennedy has been traveling to China for over 30 years. His specific areas of expertise include: industrial policy, technology innovation, business lobbying, U.S.-China commercial relations, and global governance. He is the editor of *China's Uneven High-Tech Drive: Implications for the United States* (CSIS, February 2020) and (with Jude Blanchette) *Chinese State Capitalism: Diagnosis and Prognosis* (CSIS, October 2021), and the author of *The State and the State of the Art on Philanthropy in China* (Voluntas, August 2019), *China's Risky Drive into New-Energy Vehicles* (CSIS, November 2018), *The Fat Tech Dragon: Benchmarking China's Innovation Drive* (CSIS, August 2017), and *The Business of Lobbying in China* (Harvard University Press, 2005). He has edited three books, including *Global Governance and China: The Dragon's Learning Curve* (Routledge, 2018). His articles have appeared in a wide array of policy, popular, and academic venues, including *The New York Times*, *Wall Street Journal*, *Foreign Affairs*, *Foreign Policy*, and *China Quarterly*. He is currently finishing a report, *Beyond Decoupling: Maintaining America's Hi-Tech Advantages over China* (CSIS, forthcoming Spring 2022).

From 2000 to 2014, Kennedy was a professor at Indiana University (IU), where he established the Research Center for Chinese Politics & Business and was the founding academic director of IU's China Office. Kennedy received his Ph.D. in political science from George Washington University, his M.A. in China Studies from the Johns Hopkins School of Advanced International Studies, and his B.A. from the University of Virginia.



William Klein

William “Bill” Klein is a partner with the consultancy FGS Global, where he helps the firm's global clientele navigate the growing geopolitical uncertainties of the modern world. Bill is also a senior non-resident associate at the Freeman Chair in China Studies at the Center for Strategic and International Studies (CSIS).

Before joining FGS Global in early 2022, Bill was a career member of the U.S. Foreign Service and served for over a decade in leadership roles at the heart of the U.S.-China relationship. From 2016 to 2021, he was Acting Deputy Chief of Mission, Chargé d'affaires a.i., and Minister Counselor for Political Affairs at the U.S. Embassy in Beijing. From 2013 to 2016 he was Head of the Political Section of the American Institute in Taiwan, and from 2009 to 2011 he was Deputy Director, and later Acting Director, of the Office of Chinese and Mongolian Affairs at the U.S. State Department. He also served twice in Ukraine, in India, Israel and Qatar. He holds Bachelor's and Master's Degrees in Economics from the Freie Universität Berlin in Germany, and a Bachelor's Degree in Mass Communications and History from the University of Utah. He speaks Mandarin Chinese, German and Russian.



Lee Dongmin

Dr. LEE Dongmin is an Associate Professor of Political Science and International Relations at Dankook University in Korea. Dr. Lee also currently serving as a visiting fellow at Sejong Institute. He received a Ph.D. in Political Science from the University of Colorado at Boulder, USA. Prior to returning to Korea, he served as an Assistant Professor at the S. Rajaratnam School of International Studies (RSIS), Nanyang Technological University in Singapore. Dr. Lee's research interests include international security with an empirical focus on China, and Northeast Asia. He has contributed to the academic journals such as *Armed Forces & Society*, *Defence Studies*, *Korean Journal of Defense Analysis*. Dr. Lee served as a visiting fellow at various institutes including Beijing University (IIS), Renmin University (SIS), National Chengchi University (IIR), and the East-West Center (EWC) in the United States.



Lee Sang Hyun

Sang Hyun Lee is President of the Sejong Institute in Korea. He also serves as President of the Korea Nuclear Policy Society (KNPS). He received his B.A. and M.A. from Seoul National University and Ph.D. from the Department of Political Science at the University of Illinois at Urbana-Champaign in 1999.

He was a research fellow at the Korean Institute for International Studies (1987-88), the Korea Institute for Defense Analysis (1988-90), and policy advisor for Ministry of Foreign Affairs, Ministry of National Unification, and Ministry of National Defense. He has served as Director-General for Policy Planning, Ministry of Foreign Affairs (MOFA) from May 2011 to April 2013. He is a member of Asia-Pacific Leadership Network (APLN) for Nuclear Nonproliferation and Disarmament, and Korea-US Nuclear Policy Leadership Initiative (NPLI). He has been a visiting scholar at Institute for Development and Security (ISDP) in Stockholm, Sweden, and Stimson Center in Washington DC.

His main research interests include international politics and security, Korea-U.S. relations, inter-Korean relations, nuclear security and nonproliferation, and East Asian security issues. His recent publications include: Biden Administration's Foreign Policy and the Korean Peninsula (2022, co-authored), New Global Order and South Korea's Foreign Policy Strategy (2021, co-authored), "Prospects for the Biden Administration's Foreign Policy" (2021), South Korea's Foreign Policy in the Era of U.S.-China Strategic Competition (2020, co-authored), "Trump Administration's Nuclear Policy: Implications for Global Nuclear Energy and North Korean Nuclear Issue" (2019), "Trump Administration's National Security Policy and Its Implications for Global Order and Korean Peninsula" (2018), Trump Administration and ROK-US Relations (2017, co-authored), North Korea under Kim Jong-un: Evaluating Past Five Years (2017, co-authored), and so on.



Cheng Li

Cheng Li is Director and Senior Fellow at the Brookings Institution's John L. Thornton China Center. Dr. Li is also a director of the National Committee on U.S.-China Relations, a Distinguished Fellow of the Munk School of Global Affairs and Public Policy at University of Toronto, a nonresident fellow at Yale University's Paul Tsai China Center, and a member of the Council on Foreign Relations. Li's research areas include the transformation of political leaders, generational change, the Chinese middle class, public health, Chinese think tanks, technological development in China, and U.S.-China relations.

He is the author and editor of 17 books, including more recently *Chinese Politics in the Xi Jinping Era: Reassessing Collective Leadership* (2016), *The Power of Ideas: The Rising Influence of Thinkers and Think Tanks in China* (2017) and *Middle Class Shanghai: Reshaping U.S.-China Engagement* (2021). He is currently completing a book manuscript with the working title *Xi Jinping's Protégés: Rising Elite Groups in the Chinese Leadership*. He is the principal editor of the Thornton Center Chinese Thinkers Series published by the Brookings Institution Press. Li received an M.A. in Asian Studies from the University of California at Berkeley and a Ph.D. in Political Science from Princeton University.



Moon Chung-in

Chung-in Moon is a professor emeritus at Yonsei University and editor-in-chief of *Global Asia*, a quarterly journal in English. He is also Vice Chairman of APLN (Asia-Pacific Leadership Network for Nuclear Disarmament and Non-Proliferation), and Krause distinguished fellow at School of Global Policy and Strategy at the University of California, San Diego. He was a special advisor to the ROK president for foreign affairs and national security (May 2017 to February 2021) and chairman of the Sejong Institute (2021-2023), a leading private think tank, in South Korea. He was dean of the Graduate School of International Studies, Yonsei Univ. and served as Ambassador for International Security Affairs of the Korean Ministry of Foreign Affairs and Trade and Chairman of the Presidential Committee on Northeast Asian Cooperation Initiative, a cabinet-level post. Dr. Moon was a special delegate to the first (2000), second (2007), third Korean summit (2018) held in Pyongyang. He has published over 60 books and 300 articles in edited volumes and scholarly journals.



Stephen Orlins

Stephen A. Orlins has been President of the National Committee since 2005. Previously, he was Managing Director of Carlyle Asia and Chair of cable and internet provider Taiwan Broadband Communications; a senior advisor to leveraged buyout firm AEA Investors; Managing Director of Lehman Brothers; and President of Lehman Brothers Asia. From 1976 to 1979, he was a member of the U.S. State Department's legal team that helped establish diplomatic relations with China. Mr. Orlins graduated magna cum laude from Harvard College and earned a law degree from Harvard Law School. He speaks Mandarin and is a member of the Council on Foreign Relations.



Stephen Roach

Stephen Roach served as a Senior Fellow at Yale University's Jackson Institute of Global Affairs for 13 years beginning in 2010 and as a Senior Lecturer at Yale's School of Management. In fall 2022, Roach joined Yale Law School's Paul Tsai Center China Center as a Senior Fellow.

Before coming to Yale, he was Chairman of Morgan Stanley Asia and the firm's Chief Economist for the bulk of his 30-year career at Morgan Stanley, heading up a highly regarded team of economists around the world. Roach's current teaching and research program focuses on the impacts of Asia on the broader global economy. At Yale, he has introduced new courses for undergraduates and graduate students on the “The Next China” and “The Lessons of Japan.” His writing and research also addresses globalization, trade policy, the post-crisis policy architecture, and the capital markets implications of global imbalances. Roach has long been one of Wall Street's most influential economists. His work has appeared in academic journals, books, congressional testimony and has been disseminated widely in the domestic and international media. Roach's opinions on the global economy have been known to shape the policy debate from Beijing to Washington. His latest book, *Unbalanced: The Codependency of America and China* (Yale University Press, Jan. 2014) examines the risks and opportunities of what is likely to be the world's most important economic relationship of the 21st century. His 2009 book, *The Next Asia: Opportunities and Challenges for a New Globalization* (Wiley), analyzes Asia's economic imbalances and the dangers of the region's excess dependence on overextended Western consumers. Prior to joining Morgan Stanley in 1982, Roach served



on the research staff of the Federal Reserve Board and was also a research fellow at the Brookings Institution. He holds a Ph.D. in economics from New York University. Roach is a member of the Council on Foreign Relations, the Investment Committee of the Metropolitan Museum of Art, the China Advisory Board of the Environmental Defense Fund, and the Economics Advisory Board of the University of Wisconsin.



Susan Shirk

Susan Shirk is one of the most influential experts working on U.S.-China relations and Chinese politics in the U.S. She is a research professor and the founding chair of the 21st Century China Center, a unique academic research center and university-based policy think tank at the School of Global Policy and Strategy.

Shirk held the Ho Miu Lam Chair in China and Pacific Relations for many years and is director emeritus of the University of California's Institute on Global Conflict and Cooperation (IGCC). She is the author of many books, including most notably *The Political Logic of Economic Reform in China* and *China: Fragile Superpower*, the latter of which helped frame the policy debate on China in the U.S. and other countries. She is currently working on a new book tentatively entitled, *Overreach: How China's Domestic Politics Derailed its Peaceful Rise*.

Besides her academic work, Shirk is also known for her extensive policy experience, especially in U.S.-China relations. From 1997-2000, Shirk served as Deputy Assistant Secretary of State in the Bureau of East Asia and Pacific Affairs, with responsibility for China, Taiwan, Hong Kong and Mongolia. She is the founder of, and remains active in, the Northeast Asia Cooperation Dialogue (NEACD), a Track II forum for discussions of security issues among defense and foreign ministry officials and academics from the United States, Japan, China, Russia and the Koreans.

Shirk co-chairs a task force of China experts that issued its third report “China's New Direction: Challenges and Opportunities for U.S. Policy” in Sept. 2021. She is also co-chair of the UC San Diego Forum on U.S.-China Relations, an ongoing high-level forum focused entirely on the U.S.-China relationship.



Yun Sun

Yun Sun is a Senior Fellow and Co-Director of the East Asia Program and Director of the China Program at the Stimson Center. Her expertise is in Chinese foreign policy, U.S.-China relations and China's relations with neighboring countries and authoritarian regimes.

From 2011 to early 2014, she was a Visiting Fellow at the Brookings Institution, jointly appointed by the Foreign Policy Program and the Global Development Program, where she focused on Chinese national security decision-making processes and China-Africa relations. From 2008 to 2011, Yun was the China Analyst for the International Crisis Group based in Beijing, specializing on China's foreign policy towards conflict countries and the developing world. Prior to ICG, she worked on U.S.-Asia relations in Washington, DC for five years. Yun earned her master's degree in international policy and practice from George Washington University, as well as an MA in Asia Pacific studies and a BA in international relations from Foreign Affairs College in Beijing.



Susan Thornton

Susan A. Thornton is a former career U.S. diplomat who served as Acting Assistant Secretary of State for East Asian and Pacific Affairs from 2017-18. She is currently a Visiting Lecturer at Yale Law School and a Senior Fellow at the Law School's Paul Tsai China Center. Thornton is also Director of the Forum on Asia Pacific Security at the National Committee on American Foreign Policy and a non-resident fellow at the Brookings Institution.



Christopher Thomas

Christopher A. Thomas is a nonresident senior fellow in Foreign Policy at Brookings, the chairman of Integrated Insights, a board director at Velodyne LIDAR, and a visiting professor at Tsinghua University. He is also affiliated with the Brookings Artificial Intelligence and Emerging Technology Initiative.

Thomas' current research focuses on the semiconductor industry, digital transformation through the use of artificial intelligence, and the geopolitical impact of the growing technology industry in East Asia. His upcoming work looks at policy options related to potential bifurcation of the technology industry into U.S. and Chinese spheres, national economic policy and the impact on the semiconductor industry, and the role of multinational corporations in shaping global technology policy.

Thomas previously spent nine years as partner at McKinsey & Company (2011-20), where he led the firm's Asia Semiconductor Practice and served as co-managing partner for its Global Digital Strategy and Global Internet of Things (IoT) service lines. From 1999 to 2009, Thomas was with Intel Corporation, holding roles including general manager of Intel China and chief of staff to the global head of sales and marketing. He began his career as a private equity investor at The Blackstone Group in New York City.

Thomas is also the founder of the CEO Circle, a regular gathering of more than 200 Chinese C-suite leaders; and an invited member of the U.S.-China Track II Dialogues on the Digital Economy. A globally recognized expert on the semiconductor industry, global companies' strategy for competing in East Asia, as well as the cooperation and competition between the U.S. and Chinese technology ecosystems, he has published widely on those topics, including at McKinsey, Stanford, Caixin, and the

Brookings Institution.

In 2021, the State Council of the People's Republic of China recognized Thomas as a national-level foreign expert in science and technology.

Thomas received a Master of Business Administration from Stanford Business School, where he was an Arjay Miller Scholar; a Master of Arts in political science from Stanford University; and a Bachelor of Science in economics, summa cum laude, from the Wharton School of the University of Pennsylvania.



Michael Vatikiotis

Michael Vatikiotis is a writer and private diplomat. Based in Singapore for the Geneva-based Centre for Humanitarian Dialogue, he works on promoting dialogue and conflict resolution in Asia, Africa and the Middle East. He worked as Asia Director for CHD from 2006-2021 and is a now full-time Senior Adviser. In Asia, he has more than a decade of experience working to mitigate conflicts in Indonesia, Thailand and Myanmar as well as the Philippines. Formerly a BBC Correspondent and editor of the Far Eastern Economic Review, Vatikiotis has been a writer, broadcaster and journalist in Asia for thirty-five years. He has written three books on the politics of Southeast Asia, including “Blood and Silk: Power and Conflict in Modern Southeast Asia” . With family origins in the Middle East, he has lived in Egypt, Indonesia, Malaysia and Thailand as well as Hong Kong. His latest book “Lives Between the Lines: A Journey in Search of the Lost Levant” explores the origins of his family in the Middle East. He is a regular broadcaster and contributor to the opinion page of several newspapers. Vatikiotis is a graduate of the School of Oriental and African Studies in London, earned his doctorate, which was on Thailand, from Oxford University, and was awarded an honorary doctorate from the University of Maryland. He is a member of the Asia Society's International Council. He speaks the Thai and Indonesian languages fluently.



Brantly Womack

Brantly Womack is Senior Faculty Fellow at the Miller Center and Emeritus Professor of Foreign Affairs at the University of Virginia. Currently he is Boeing Visiting Faculty Chair in International Relations at Schwarzman College, Tsinghua University. He is the author of *Recentering Pacific Asia: Regional China and World Order* (forthcoming, Cambridge). Other recent books include *Asymmetry and International Relationships* (Cambridge 2016), *China Among Unequals: Asymmetric International Relationships in Asia* (World Scientific 2010), and *China and Vietnam: The Politics of Asymmetry* (Cambridge 2006).

DA Wei

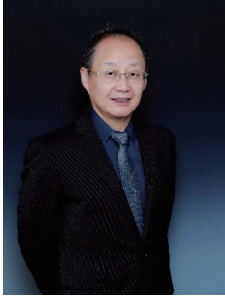

From July 1997 to August 2019, He was Senior Fellow and Director of Strategic Studies and Deputy Director of the Center for Arms Control and Nonproliferation Studies in the Institute of American Studies at Chinese Academy of Social Sciences. He was the founding Executive Editor-in-Chief of the Contemporary of American Review journal. His research interests mainly include Sino-US strategic security relationship, American arms control and nonproliferation policies. He published widely in academic journals, edited volumes, and conference proceedings. He recently authored and edited four books on American military strategy, arms control policy, and nuclear strategies. He obtained his PHD from the Graduate School of Chinese Academy of Social Sciences in 2004, and spent about two years in total in Harvard University, Stanford University, Monterey Institute of International Studies as visiting scholar.



FANG Ning

Fang Ning is a political scientist, an expert in philosophy and social science in China's Thousand Talents Plan, and the former Director and Secretary of the Party Committee of the Institute of Political Science at the Chinese Academy of Social Sciences, where he is also a researcher. He is a Chair Professor at Sichuan University.

In his long academic career in political theory and practice, Professor Fang has participated in many important research projects and in writing theoretical works for state ministries. In September 2010, he gave a lecture titled On the Correct Handling of Contradictions Among the People in the New Era at the 23rd collective study session of the Politburo of the 17th Central Committee of the Communist Party of China (CPC), and in April 2013, he gave a lecture on Anti-Corruption and Integrity in the History of China at the 5th Politburo collective study session of the 18th CPC Central Committee.

Professor Fang has always been committed to the pursuit of learning with his feet on the ground—in 2017, he visited the Beijing-Hangzhou Grand Canal on foot, and in 2021, he embarked on a field study of the Aihui-Tengchong Line.



FU Ying

Fu Ying started her career with China's Ministry of Foreign Affairs (MFA) in 1978 and had long experience in Asian and European affairs. She was appointed Ambassador to the Philippines in 1998, and Director General of Asian Department of MFA in 2000. She then was appointed Ambassador to Australia (2004-2007), and Ambassador to the United Kingdom (2007-2009). She served as Vice Minister of Foreign Affairs for European Affairs and then for Asian Affairs (2009-2013).

Fu Ying was elected deputy to China's 12th (2013) and then 13th (2018) National People's Congress (NPC). She was the Chairperson of the Foreign Affairs Committee and spokesperson of the 12th NPC (2013-2018) and a Vice-Chairperson of the Foreign Affairs Committee of China's 13th NPC (2018-2023).

Fu Ying also Chaired the Center for International Security and Strategy (CISS) and was appointed an adjunct professor at Tsinghua University from 2018 to 2021.



GU Ning

Dr. Gu Ning is an associate professor in the School of Politics and Public Administration at Xinjiang University. He used to serve as an associate research fellow at the Department for Developing Countries Studies at the China Institute of International Studies under the Ministry of Foreign Affairs of China and a visiting scholar at the Oxford Centre for Islamic Studies. Dr. Gu is the co-author of seven monographs and author of 14 academic and conference papers. He has also published 35 articles in People's Daily, Guang Ming Daily, Outlook Weekly and other publications.



HU Bo

Hu Bo is Director of the Center for Maritime Strategy Studies and Research Professor at the Institute of Ocean Research, Peking University and Fellow of CISS, Tsinghua University. His areas of specialization include maritime strategy, international security, and Chinese diplomacy. He has written three books and more than 40 journal articles and book chapters on topics related to China's maritime strategy and policy. HUANG Renwei

Academic Committee Member, CISS, Tsinghua University; Executive Vice President, Fudan Institute of Belt and Road and Global Governance. Former Vice President of Shanghai Academy of Social Sciences, Senior Fellow for International Studies; Honored Chairman of Shanghai Association For American Studies.

Published many books and articles on Global governance, Sino-US relations, Asia Regional Cooperation, International Trade and Cross Strait relations. His books including The Time and Space of China's Rise have been widely quoted; and participated in many second-track strategic dialogues between China and US.

Dr. Wu has a PhD in history. His research interests cover the history and geography of the South China Sea, maritime delimitation, maritime economy, international relations and regional security strategy. XIAO Qian

XIAO Qian is the Vice Dean of the Institute for AI International Governance (I-AIIG) and Deputy Director of the Center for International Security and Strategy (CISS) at Tsinghua University.

From 2003 to 2014, she served in the Ministry of Foreign Affairs as well as the Chinese Embassies in Russia and in the UK. She worked in the Foreign Affairs Committee of the National People's Congress (NPC) in 2015, where she contributed to parliamentary engagement and work related to the NPC Spokesperson's Office.

From 2015 onwards, she has been engaged in the establishment of the National Institute for Global Strategy of the Chinese Academy of Social Sciences and its subsequent operation, where she worked on the organization of a series of events including U.S.-China Manor Forum, Joint U.S.-China Think Tank Project, U.S.-China High-level Experts Dialogue, and Weekend Forum on Security and Strategy.

In January 2019, Ms. Xiao joined Tsinghua University in the establishment and development of CISS and I-AIIG. In addition, she is the Vice Dean of International Affairs, Tsinghua University.



XUE Lan

Academic Committee Member, CISS, Tsinghua University, Dean, Schwarzman College, Tsinghua University. Dr. XUE Lan is a Cheung Kong Chair Distinguished Professor. His teaching and research interests include STI policy, crisis management, and global governance. He also serves as an adjunct professor at Carnegie Mellon University and a Non-Resident Senior Fellow of the Brookings Institution. He is a member of the National Committee for Strategic Consultation and Comprehensive Review, a member of United Nations University Council, and a Co-Chair of the Leadership Council of the UN Sustainable Development Solution Network (UNSDSN).

Dr. Xue received his Ph.D. in Engineering and Public Policy from Carnegie Mellon University in 1991, and taught at the George Washington University as an assistant professor before returning to Tsinghua University in 1996. He has won many awards and prizes for his work, including Distinguished Young Scholar Award of National Natural Science Foundation of China (NSFC), and Fudan Distinguished Contribution Award for Management Science.



YAN Xuetong

Yan Xuetong is an Academic Committee Member of CISS, Tsinghua University and a distinguished professor of Tsinghua University and a member of Russia Academy of Sciences. He is serving as the Dean of the Institute of International Relations at Tsinghua University and the Secretary General of the World Peace Forum. He obtained Ph.D. from University of California, Berkeley in 1992 and was named as one of world's Top 100 public intellectuals by the American journal Foreign Policy in 2008. He has been the only political scientist listed in Most Cited Chinese Researchers by Elsevier since 2014. Some of his books have been translated into English, Japanese, Korean, Farsi or Albanian.



YANG Bojiang

Yang Bojiang serves as the director-general, professor and doctoral supervisor, the Institute of Japanese Studies, CASS; director, Research Center for East China Sea Studies, CASS; executive vice president, the Chinese Association of Japanese Studies; vice president, the Chinese Association of Asia-Pacific Studies and executive member of the council, Pacific Society of China (PSC). He is the national "ten thousand people plan" philosophy and social science leading talent, cultural master and "four one batch" talent, the State Council government special allowance scholar. He has been a visiting scholar at the Fairbank research center, Harvard University, Brookings Institution, the Japan Forum on International Relations and the National Institute for Research Advancement (NIRA). His academic interests include relations among major powers in the Asia-Pacific region, Northeast Asia and Japan.



YU Xiang

YU Xiang is National Outstanding Young Scholar, Nonresident Senior Fellow at the Center for International Security and Strategy(CISS), Tsinghua University, China Forum expert, and Senior Research Fellow at China Construction Bank. Prior to current positions, Dr. YU was the Deputy Director of Center for Social and Economic Center, Director of Division of American Economic Studies at the China Institutes of Contemporary International Relations (CICIR). YU supervised the Master Program of study at the China University of International Relations. ZHAI Kun

Zhai Kun is a professor at the School of International Studies and the deputy director of the Institute of Area Studies at Peking University. He also serves as the Vice President of China Society for Southeast Asian Studies and the Vice President of China Society of Emerging Economies. His research focuses on Southeast Asia, the Belt and Road Initiative, international strategy, and world politics. He teaches courses on the basic theories and methods of area and country studies, politics, economy, and diplomacy of Southeast Asia, China's international strategy and practice, and the Belt and Road Initiative. Some of his representative works include "Five Connectivity Index Reports of Countries along the Belt and Road Initiative (2017)" (published by the Commercial Press in 2018), "Building a Community with a Shared Future for Youth under the Belt and Road Initiative " (published by the Commercial Press in 2018), "Case Studies and Risk Prevention of the Belt and Road Initiative" (published by the Ocean Press in 2017), and "Visionary in the World (Volume 1)" (published by World Affairs Press in 2022).



ZHANG Lirong

Mr. ZHANG Lirong is now the Secretary-General of China Forum, CISS, Tsinghua University. He's a former career diplomat. He worked in the Department of Western European Affairs and the Information Department of the Foreign Ministry, the People's Republic of China. He was once secretary to the Vice Foreign Minister in charge of Asia, the Middle East and Africa. He also worked for years in the Central Foreign Affairs Office of CPC (Chinese Communist Party) as well as Foreign Affairs Office of JIANGSU Province. Through the years he was promoted from staff member to Deputy Director, Director and Deputy Director-General.

He took up various assignments in the Chinese Embassy in Denmark and in the United Kingdom as well as in the Chinese Mission to the European Union, respectively as Counsellor, Minister Counsellor and Minister.



ZHANG Tuosheng

Professor Zhang Tuosheng is a Senior Fellow of the Academic Committee, as well as the director of the Center for Foreign Policy Studies at the China Foundation for International and Strategic Studies. He is also a council member of the Chinese People's Institute of Foreign Affairs, the Chinese Arms Control and Disarmament Association, the Academy of International and Strategic Studies of Peking University and a member of the Academic Committee of CISS, Tsinghua University. Previously, he was the deputy defense attache at the Chinese Embassy in the UK, research fellow in the Institute of Strategic Studies of People's Liberation Army (PLA) National Defense University and a lecturer at the PLA Military Collage. His main research interests are China-US relations, China-Japan relations, Asia-Pacific security, security crisis management and China's foreign policy. He has authored or co-authored lots of research publications including papers, reports and books. He earned his master degree from Central Party School of the Communist Party of China.



ZHANG Baijia

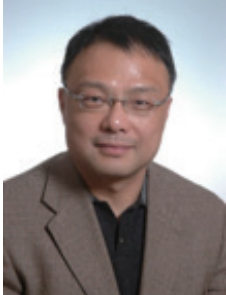


ZHOU Bo

Senior Colonel Zhou Bo is an under-graduate of Air Force Engineering College and a postgraduate of St Edmund College of Cambridge University (Mphil in International Relations).



ZHU Feng

Zhu Feng is currently Executive Director of China Center for Collaborative Studies of the South China Sea, Nanjing University. He is also Director of the Institute of International Studies at Nanjing University. He writes extensively on regional security in East Asia, the nuclear issue in North Korea, China-US military and diplomatic relations. As a leading Chinese security expert, Professor Zhu's recent book includes *International Relations Theory and East Asian Security* (2007), *China's Ascent: Power, Security, and Future of International politics* (co-edited with Professor Robert S. Ross, Cornell University Press 2008), *China-Japan Security Cooperation and Defense Communication: the Past, Present, and Future* (Co-edited with Prof. Akiyama Asahiro, Tokyo: Aiji Press, 2011), and *America, China and the Struggle for the World Order* (co-edited with Prof. G. John Ikenberry and Prof. Wang Jisi, MacMillan, 2015). He sits on a couple of editorial boards of scholarly journals, consults independently for the Chinese government and the private sector, and comments frequently on television and radio and in the print media on Chinese foreign affairs and security policy.



ZOU Ji

Zou Ji is a Fellow at CISS, Tsinghua University. He previously served as a deputy director general of China's National Center for Climate Change Strategy and International Cooperation. Between 2012 and 2015 and between 2000 and 2009, Prof. Zou was a key member of the Chinese climate negotiation team leading up to the Paris Agreement. Between 2013 and 2014, he served as a China representative to the United Nations Intergovernmental Committee of Experts on Sustainable Development Financing.

Prof. Zou was a vice dean, professor, and doctoral supervisor at the School of Environment and Natural Resources, Renmin University in Beijing. He holds a bachelor's degree in Environmental Engineering and a master's in Technical Economics, both from Tsinghua University, and a Ph.D. in Resources and Environmental Economics from Renmin University.
