# Ms Louise Watson Chairman, the Global Foundation

# Dr Mark Cutifani CBE Chair, Global Advisory Council, the Global Foundation; Chairman and Acting CEO, Vale Base Metals

Mark is a mining engineer by training having started his career in deep underground coal mining in Australia in 1976. In his +46 years of experience, he has had line and support responsibilities across all forms of mining, processing, and product marketing, having worked across 6 continents, 20 countries and with more than 30 minerals and metals. He is recognized as a major industry leader and innovator with a track record for delivery of improvements across all facets of business performance.

Mark retired from his role as the Chief Executive Officer (CE) of Anglo American (AA) in April 2022 after more than 9 years and delivering the significant restructuring and revitalisation across all facets of its global mining business. In his period of tenure, AA delivered industry leading capital and shareholder returns underpinned by a doubling of employee productivity, with associated material cost reductions and improvements in capital returns. At the same time AA moved from lagging industry performance in sustainability and innovation to being an acknowledged leader in value creation through new and progressive social, technical, and commercial transformations.

Prior to his AA position he was the Chief Executive Officer (CEO) for AngloGold Ashanti. Mark was responsible for the recovery and turnaround of the business after successfully dealing with the industry's most significant "out of the money" gold hedge book. Mark has also held senior executive positions with the Inco and Vale, the Normandy Group, Sons of Gwalia, Western Mining Corporation, Kalgoorlie Consolidated Gold Mines and CRA (Rio Tinto). Mark was also a past President of the International Council for Mining and Metals (ICMM) and the South African Chamber of Mines (now Minerals Council).





### Ms Sharan Burrow Deputy Chair, Global Advisory Council, the Global Foundation; Global Advocate for Rights and Sustainability

Sharan Burrow is a global advocate for human rights, climate action and Just Transition. She is the Former General Secretary of the International Trade Union Confederation (2010-2022. Previously she was President of the Australian Council of Trade Unions (2000–2010.)

Sharan is well known for her international advocacy on employment, human rights, industrial relations, corporate responsibility and climate action with just transition solutions.

#### Secretary General, the Global Foundation

As founding Secretary General of the non-profit Global Foundation since 1998, Steve Howard has led the necessary global push for the adoption of 'co-operative globalisation', a holistic and long-term strategy to enable a sustainable global common good.

Much of Steve's work with the Global Foundation has involved aligning leaders from the private sector, civil society, academia, faiths and institutions, and sometimes from governments, from across the world, in defining and striving for a shared global vision, backed up by concrete actions.

# Ms Shiva Lynn Burgos Founder, The Mariwai Project, Papua New Guinea

Shiva Lynn Burgos is the first international contemporary artist to work in Mariwai, a small Kwoma village located in the Upper Sepik River, Papua New Guinea. Although it is not part of Kwoma custom for women to paint and carve she was accepted as an artist and invited into the Kiava clan. She was taught traditional styles and contributed carvings and paintings to the new ceremonial house being built in Mariwai. She created The Mariwai Project in 2014, a wide-ranging and long-term arts project and cultural exchange with the indigenous artists which includes philanthropic support for art, culture, health, education and development in the region. She is appointed by the PNG ministry of Culture to develop PNG arts and culture projects and partnerships internationally, including the first PNG Pavilion at the Venice Art Biennale 2026.

#### Prof Francis Campbell Vice-Chancellor, the University of Notre Dame Australia

In February 2020, Professor Campbell became the fourth Vice Chancellor of The University of Notre Dame Australia. He also holds the position of Professor, International Relations. He was previously the Vice Chancellor at St Mary's University, London.

He is currently serving as a Trustee of Forward Thinking (London), a Governor of the Forrest Research Foundation, member of the Association of Catholic Colleges and Universities Board of Directors and is a founding member of the International Council on Human Trafficking at St Thomas University, Miami, School of Law.

Previously Professor Campbell served in the Foreign and Commonwealth Office, 10 Downing Street, the United Nations Security Council in New York, the European Union and Amnesty International.

# Fr Simone Ceccobao Friar of Assisi, Eremo delle Carceri

Fr. Simone Ceccobao is a Franciscan friar currently serving as the Padre Guardiano (father custodian) at the Eremo delle Carceri, a historic hermitage located near Assisi, Italy. This position involves serving as the spiritual leader and guardian of the small community of friars who reside at the hermitage, which is known for its deep spiritual and historical significance tied to St. Francis of Assisi.

The Eremo delle Carceri, situated on Mount Subasio, is a place where St. Francis and his early followers would retreat for prayer and contemplation. The term "Carceri" comes from the Latin "carcer," meaning isolated or solitary places, rather than prisons. This serene and secluded spot continues to be a refuge for those seeking spiritual solace and reflection, maintaining a strong connection to nature and simplicity, much in the spirit of St. Francis himself.

Fr. Simone, originally from Tuscany, has been noted for his dedication to preserving the spiritual heritage and tranquility of the hermitage, ensuring that it remains a place of peace and prayer for visitors and residents alike.

# Founder, Systemic Renewal

Heather helps leaders get results who are trying to effect change in the hardest places. She is the creator of Systemic Renewal, an action research method that works to discover what essential good has been lost in a system and to reclaim it.









Heather has combined twenty years of experience in community development, four years of doctoral research and a lifetime of personal renewal to understand the pedagogy that leaders use to restore systems that appear 'too far gone.' She has worked in a range of settings including student support for international students, renewing NGO's facing liquidation, supporting faith communities recovering from abuse and legal practice in disadvantaged communities.

She holds degrees in Law, Theology, Education, and Leadership Studies, and is currently completing her PhD, developing a pedagogy for systems change inspired by Franciscan social reform. Enrico Giovannini is full professor of Economic statistics and Sustainable development at the University of Rome "Tor Vergata" and professor at the National School of Administration (SNA). He was Minister of Sustainable Infrastructures and Mobility in the Draghi government (February 2021 – October 2022) and Minister of Labour and Social Policies in the Letta government (April 2013 – February 2014). He is co-founder and Scientific Director of the Italian Alliance for Sustainable Development (ASviS), a coalition of more than 300 organisations established to implement in Italy the UN 2030 Agenda. He was Director of Statistics and Chief Statistician of the OECD (2001-2009) and President of the Italian Statistical Institute (2009-2013). In October 2014, the President of the Italian Republic made him "Cavaliere di Gran Croce al Merito della Repubblica", the highest ranking honour of the Italian Republic and in January 2023 he received a honorary PhD in "Sustainable development and climate change". He is the author of more than 130 articles published on national and international journals and seven books on statistical and economic topics.

CCG is the only non-governmental think tank with the qualification for independent establishment of post-doctoral research workstations issued by government.

Dr. Miao also serves as Founder and Secretary General of Global Young Leaders Dialogue (GYLD) program, Deputy Director General of the Alliance of Global Talent Organizations (AGTO), Secretary General of China Global Talent Society, Secretary General of Policy Advisory Committee of Western Returned Scholars Association (WRSA) and Deputy Director-General of the International Writing Center of Beijing Normal University.

Dr. Miao holds a Ph.D degree in Modern and Contemporary Chinese Studies from Beijing Normal University. She was also a visiting fellow at New York University and Harvard University, a post-doctoral fellow of the Hong Kong University of Science and Technology (HKUS), and a Lien Fellow at Nanyang Technological University (NTU), Singapore.

# Prof Miriam Mirolla Chair of Psychology of Art & Theory of Perception and Psychology of Form, Academy of Fine Arts Rome

Born in Naples, Miriam Mirolla lives and works in Rome.

Her general interests span art psychology, education, avant-garde theories, philanthropy, digital humanities, gender studies, citizenship. In 1986 she joins the Eventualist Theory at Jartrakor research center in Rome. In 1991 she had her Bachelor at La Sapienza University in Rome, and a few months later she was called as Intern curator at P.S.1 Institute for Contemporary Art, New York. Professor in several Academies of Fine Arts and Universities, she published scientific papers, conference papers, books as well as she curated group and solo exhibitions.

As an Experimental Artist, she realized numerous exhibitions and experiments, as documented in the book "Miriam Mirolla, Experiments in Art" (2017), by E. Melchiorre. ## Archbishop Vincenzo Paglia President, Pontifical Academy for Life

Archbishop Vincenzo Paglia is an Italian prelate of the Catholic Church. He is the president of the Pontifical Academy for Life and grand chancellor of the John Paul II Pontifical Theological Institute for Marriage and Family Sciences.

Paglia was president of the Pontifical Council for the Family from 2012 to 2016 and Bishop of Terni-Narni-Amelia from 2000 to 2012. He was also a co-founder of the Community of Sant'Egidio in 1968. Paglia was the postulator for the cause of canonization of Óscar Romero and of Felix Varela.

#### H.E. Cardinal Pietro Parolin

#### Secretary of State of His Holiness, Pope Francis, The Holy See

Cardinal Pietro Parolin was born in Schiavon (Italy) on January 17, 1955. He was ordained as a priest on April 27, 1980 in Vicenza, his diocese of origin and, after spending several years at the pastoral ministry, he began studying law. He completed his studies in 1986, graduating with a Degree in Canon Law from the Pontifical Gregorian University and a diploma in Diplomatic Sciences from the Pontifical Ecclesiastical Academy, where he had begun studying in 1983. Joining the Diplomatic Service of the Holy See in 1986, he offered his services at the Apostolic Nunciatures in Nigeria and Mexico, and, for 17 years, in the Section for Relations with States of the Secretariat of State, later becoming Undersecretary (2002-2009). In August 2009, he was appointed Titular Archbishop of Aquipendium and Apostolic Nuncio to Venezuela. In August 2013, he was made Secretary of State by His Holiness Pope Francis, who has also invited him to join the College of Cardinals in the Papal Consistory on February 22, 2014.

#### Professor of Philosophy, Tor Vergata University of Rome

Pozzo is a philosopher with a background in logic and philosophy of science. His approach relies on the use of concept modelling for textual content documentation and elaboration. During his tenure at CNR, he pushed forward the participation of Italy to the European research infrastructures for social sciences and humanities CESSDA, CLARIN, DARIAH, EHRI, ERIHS, ESS, OPERAS, RESILIENCE, and SHARE. He served as President of the Regional Episcopal Conference of West Africa (RECOWA) (2007-2010). He was also Chairman of the Ghana Chapter of the Conference of Religions for Peace (2003-2007) and Ghana National Peace Council (2006-2010).

On 24 October 2009 he was nominated President of the Pontifical Council for Justice and Peace. On September 24, 2013, he was confirmed by Pope Francis as President of the Pontifical Council for Justice and Peace.
