
The Project has identified, and is linking, key figures from five sections of global society.




Assisi & the Chapel of St Francis

For several years, with the encouragement of the Mayor of Assisi, the Foundation has convened global roundtable discussions in the beautiful Italian hillside town of Assisi; the birthplace of Saint Francis. In June 2023, the **Franciscan Friars of Assisi** asked the Global Foundation to support their proposal to build a new chapel in the woods of the Hermitage, a sanctuary outside of Assisi, which was an important ecological retreat for St Francis 800 years ago.
