Abrão Neto, CEO, Amcham Brasil

Abrão Neto previously served as Secretary of Foreign Trade. He has over 18 years of experience in international affairs and public policy, having held prominent positions in both the public and private sectors. From 2016 to 2018, he served as Secretary of Foreign Trade at the Ministry of Industry, Foreign Trade and Services (MDIC). Between 2013 and 2016, he also held the position of Director for International Negotiations and served in various other roles within the federal

government. Earlier in his career, Abrão worked as a coordinator in the international relations and foreign trade department at FIESP and practiced as a lawyer specialized in international trade. He holds a Ph.D. in International Law from the University of São Paulo (USP), a Master's degree in International Economic Law from the Pontifical Catholic University of São Paulo (PUC-SP), and was a visiting Ph.D. researcher at Georgetown University in the United States. He is also a Senior Fellow at the Atlantic Council, a Washington, D.C.-based think tank, and teaches international relations at ESPM.



Alex Dias Carvalho, President, Federation of Industries of the State of Pará (FIEPA)

Alex is a civil engineer with 25 years of experience. He graduated from the University of the Amazon (Unama) and holds a master's degree in Transport Infrastructure from the Polytechnic School of the University of São Paulo (USP). He currently serves as Vice President of the Brazilian Chamber of the Construction Industry (CBIC), where he has been active for over 12 years, and as

Vice President of the Infrastructure Thematic Council at the National

Confederation of Industry (CNI). He also held the presidency of the Construction Industry Union of the State of Pará (Sinduscon) for two consecutive terms. As Vice President of FIEPA, he represented the institution on the State of Pará's Economic Development Council (CDE) and served as a member of the Fiscal Council of SESI Pará. He has actively participated in several forums and thematic events related to infrastructure, tax incentives, environmental licensing, and labor relations, both within FIEPA and in partnership with other industry organizations.



Alistair Dutton, Secretary General, Caritas Internationalis

Alistair was elected Secretary General of Caritas Internationalis after having served as Chief Executive of Caritas Scotland for nine years. Previously, Alistair had been Caritas Internationalis' Humanitarian Director for five years and interim Director of The Sphere Project, which sets international standards for humanitarian aid. An engineer, Alistair studied physics at the University of Durham, and philosophy, politics and economics at the University of Oxford. Alistair has worked in the international relief and development sector for more

than twenty-five years, during which time he has worked in more than sixty countries in Africa, Asia, Latin America, the Caribbean, Eastern Europe and the Middle East. Alistair entered the sector when, as a Jesuit novice working for the Jesuit Refugee Service, he was seconded to Caritas Nepal.

Aloizio Mercadante, President, Brazilian Development Bank (BNDES)

Aloizio Mercadante Oliva, President of the National Bank for Economic and Social Development (BNDES), is an economist who graduated from the School of Economics and Business Administration at the University of São Paulo (USP, 1976). He holds a master's degree in Economics from the Institute of Economics at the State University of Campinas (Unicamp, 1989) and a Ph.D. in Economic Theory from the same institution (Unicamp, 2010). He is a retired professor of

economics at Unicamp and a tenured professor (on leave) from the Department of Economics at the Pontifical Catholic University of São Paulo (PUC-SP). He served as president of the Student Athletic Association and the Academic Center at FEA-USP (1973-74), president of the Association of PUC Professors (APROPUC) (1978–87), and co-founder and vice-president of the National Association of Higher Education Faculty (ANDES) (1980-84). Mercadante participated in the founding of the Workers' Party (PT) in 1980, serving as vice-president and director of international relations of the party's National Executive Committee. He was also one of the founders of the Unified Workers' Central (CUT), where he became the first director of the Department of Social, Economic and Political Studies (DESEP) in 1984. He was elected federal deputy for the Workers' Party (PT) for two terms (1991-1995 and 1999-2003), serving as Chair of the Economic Affairs Committee and as Leader of the PT caucus in the House of Representatives. Mercadante ran as vice-presidential candidate alongside Luiz Inácio Lula da Silva in the 1994 presidential election. He was elected Senator for the State of São Paulo (PT) for the 2003–2011 term, becoming the most voted senator in Brazil's history at the time, with 10.5 million votes. In the Senate, he served as Chair of the Economic Affairs Committee, Leader of the Government Support Bloc, Leader of the PT caucus, Leader of the National Congress, member of the Brazilian delegation to Mercosur, and President of the Mercosur Parliament from 2007 to 2010. He served as Minister of Science, Technology and Innovation (2011–2012); Minister of Education (2012–2014); Chief of Staff of the Presidency of the Republic (2014–2015); and again as Minister of Education (2015-2016) during the governments of President Dilma Rousseff, of the Workers' Party.



André Corrêa do Lago, Ambassador, Secretary for Climate, Energy and Environment of the Brazilian Ministry of External Affairs and President of COP 30 Trustee at the Brazilian Center for International Relations. Diplomat since 1983. Is Secretary for Climate and Environment of the Ministry of External Affairs. Was Ambassador to India (2019-2023) and to Japan (2013-2018). In the field of architecture, he is an author, curator, and jury member. He has been a member of the Pritzker Award jury for three years. He is also a member of the jury for the

Instituto Moreira Salles (IMS) competition in São Paulo and the jury for the new headquarters of the Institute for Pure and Applied Mathematics (IMPA) in Rio de Janeiro. He has worked in several areas at the Ministry of Foreign Affairs, mainly in the environmental area. He was Brazil's chief negotiator for Climate Change and Sustainable Development, including at Rio+20. He worked in Madrid, Prague, Washington, Buenos Aires, Brussels. He was Ambassador to Japan for five years.









Anna-Julia McVeigh, Head of Strategic Engagement, Nature Positive Initiative Secretariat

Anna-Julia is a passionate advocate for climate and nature within business and NGO settings. Her mixed heritage from Brazil and the UK are ever present in her interactions, both personal and professional. At the Nature Positive Initiative, she brings her strategy and partnerships experience to the small secretariat team to help enable more strategic relationships to scale Nature Positive. She brings 15+ years of consulting experience, most recently leading a practice in Accenture

Development Partnerships on Climate & Environment, championing their expansion into Nature & Biodiversity topics with clients in the environmental NGO sector. She has expertise in organisational strategy and visioning as well as designing transformational change journeys. He coined the concept of powershoring, which advocates

relocating energy-intensive industries to regions with clean, low-cost energy, such as Latin America and the Caribbean, to support decarbonization and inclusive growth. Arbache has held senior roles at CAF – Development Bank of Latin America and the Caribbean, the World Bank, the International Labour Organization, and Brazil's Ministry of Planning. He is a regular columnist at Valor Econômico, where he writes on trade, competitiveness, and sustainability. Widely regarded as a leading voice on Latin America's role in the global green transition, his contributions have shaped key economic and policy debates across the region.

Juan Merlini joined Vale in 2006, serving in Strategic Planning, Corporate Finance, and Global Treasury. From July 2018 to June 2023, he was a member of the Senior Leadership team at Vale Base Metals in Toronto, first as CFO and Head of Business Development, then as Global Head of Sales and Marketing. In July 2023, he became Head of Strategy and Marketing for Iron Ore, based in Singapore, and as of March

2025, he also leads the Global Ferrous Technology Center and New Ventures, based in Rio de Janeiro. Juan holds a degree in Electrical Engineering from PUC-MG, a postgraduate degree in Finance from FGV, and an MBA in Finance from IBMEC.

Additionally, in 2019, she received the Sabiá Laranjeira Award, offered by the Sustainable Leader Platform to activist leaders, and is the current President of the Board of the Brazil Climate Summit event. She is also part of the technical advisory board of the Climate Hub, launched by the Columbia Global Center, in Rio de Janeiro. Luciana holds a law degree from the University of São Paulo (USP) and an MBA from Columbia Business School.

Marcelo Behar, Special Envoy for Bioeconomy, COP30

Attorney and public policy expert who leads climate initiatives as Senior Advisor to WBCSD and CEBDS for COP30. He was the Vice-Minister for Strategic Affairs (2003-2008) and head of the Federal Disarmament Campaign, followed by fifteen years as a C-Level executive at sustainability-focused companies including CSN and Natura. He co-founded Ambition Loop Brazil, and currently coordinates FGV-SP's Climate Governance Forum and serves on the boards of organizations
